David Allison declared a quorum and called the hearing to order at 7:32 p.m. The City of Petal initiated this variance hearing to appeal Dan Tolbert's (Building Official) decision to allow Obbe Peanut Company to place an Inchouse on the property in the existing C-1 zoning district. Buck Anderson, Dobe Peanut Company, presented the variance request to the Variance Committee. Hir. Anderson stated that the ice machine is convenient and user-friendly. He explained what the machine does and the amount of ice it can give out. He also stated that the unit does not politize nor does it use sewage. It only requires electricity and water and is inspected by the Health Department. Mr. Anderson displayed plotumes of the current shopping center and gaive example of ways he has in mind to improve the area with the placement of the loe house. He stated that he would like to pave the area to make it large enough for an RV, boat, etc., have an elevated extended patio area with foliage and landscaping.

David Allison asked for questions from the Variance Committee. Hr. Allison asked about how much revenue is expected from this machine. Mr. Anderson stated that it could be as much as \$140,000 and sales tax is included with each bag sold. There will also be two people who will maintain the machines and grounds, but they will be there aneeded. Dan Tolbert asked if there were a storm that disrupted power, would they have the ability to put a generator on it. Mr. Anderson stated that it would be up within eight hours of the power outage.

David Allison asked for questions from the public. Jim Smith spoke in support of Mr. Anderson and his contributions to the community and school district. Mayor Carl Scott stated that the Variance Committee needs to decide if this lochouse belongs in the C-1 zoning or if the machine is in fact considered manufacturing. According to the Mayor's research, the licehouse is technically manufacturing because a substance is changed

from one form to another and the ice is bagged mechanically. He stated that the structure could be allowed in an I-1 or I-2. Alderman James Moore, stated that he would like to see the icehouse in Petal but not in its current location. He also stated that he would have no problem granting a variance for a C-1 or C-2 zoning, but in a less intrusive location. Hugh Garraway, a resident of Sherwood Forrest, stated that he does not like the way the trailer looks and that it is not aesthetically pleasing.

David Allison asked for a recommendation from Dan Tolbert. Mr. Tolbert gave the definition of a variance. He also stated that the Variance Committee should not base their decision on the appearance of the structure, but should determine whether or not the Icehouse should be considered manufacturing. Mr. Tolbert stated that he stands by his decision to allow the icehouse in its present location.

David Allison called for discussion from the Variance Committee members. Alex Powe stated that since the City gave permission that the City should stand behind the decision because Mr. Anderson has invested money in the icehouse. Nollie Beaumont stated that the structure is not aesthetically pleasing but would like to see one in Petal but not in its current location. But he also fist that the City would have to stand behind the original decision to allow the icehouse at that location. David Allison stated that he believes that the machine is manufacturing and could not vote to approve it.

The Variance Committee voted for granting a variance by a show of hands with the following result:
