Re: Utility bill adjustment

Mr. Raymond M. Baum, Esq. Attorney

Dear Mr. Baum:

Attorney General Jim Hood has received your request for an official opinion and has assigned it to me for research and response. Your letter reads and inquires, as follows:

I have been requested by the Mayor and Board of Alderman of the Town of Duck Hill, Mississippi to request an opinion from your office regarding the following matter:

1. May the Town of Duck Hill adjust a customer's bill for natural gas service when that customer has had a gas leak?

In response to your inquiry, it is clear that forgiveness of debts owed to a municipality is prohibited as such would amount to a violation of Mississippi Constitution Article 4, Section 100. MS AG Op., Kerby (December 5, 2003). We have consistently opined that while a municipality may not reduce or forgive a utility bill of a customer as a donation for the benefit of that customer, a municipality may "reduce a utility bill unreasonably increased because of unforseen circumstances and forwhich the customer did not receive the benefits of the utility service." MS AG Op., Horton (August 24, 2007); MS AG Op., Rose (September 6, 2002); MS AG Op., Howell (July 16, 2001). In such an instance, the municipality may negotiate the settlement of a doubtful claim and such a reduction depends upon the facts and circumstances of the case. MS AG Op., Gay (May 9, 1994). Thus, it is the opinion of this office that in the event that the governing authority determines that a utility bill charge wasdue to an unforseen circumstance and the customer did not receive the benefit of the utility service, it may adjust the utility bill accordingly. A copy of the above referenced opinions have been provided for your review.
