AN ORDINANCE TO AMEND ORDINANCE NUMBER 1979 (44-M)
TO AMEND THE AMOUNTS TO BE CHARGED FOR COLLECTION
AND DISPOSAL OF GARBAGE, TRASH AND FOR RELATED PURPOSES

BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF PETAL, MISSISSIPPI:

SECTION 1 of Ordinance 1979 (44-M) and other appropriate sections of the original ordinance 1979 as amended, are amended to read as follows, to wit:

SECTION A. The following fees are established for the collection, removal, and/or disposal of garbage and trash.

- For each residence within the City of Petal, the sum of twenty dollars and no cents (\$16.00) per month;
- $b. \qquad \text{For apartment complexes of two or more units, the sum of twenty dollars and} \\ \\ \text{no cents ($16.00) per apartment, per month;}$
- c. For all apartment complexes of two or more units not using city garbage collection services, the sum of ten dollars and no cents (\$10.00) per apartment, per month for trash collection services.
- For mobile home parks the sum of twenty dollars and no cents (\$16.00)
 per mobile home unit, per month;
- e. For all other garbage collection customers, the sum of twenty dollars and no cents (\$20.00) per month provided a garbage pick up is not required to be made more than once in any one week;
- f. For other collection services, other than residential (home/apartments/mobile home parks) such as businesses, small industries, or those requiring special handling, or more than one collection per week, a fee is to be determined by application of Section 1-12 of Ordinance 1979 (44), as amended.

SECTION 2. That except as otherwise amended herein, Ordinance 1979 (44) and amendments A, B, C, D, E, F, G, H, I, J, K, L AND M shall remain in full force and effect.

SECTION 3. This Ordinance shall be in full force and effect from and after January 1, 2010.

BE IT ORDAINED by the Mayor and Board of Aldermen of the City of Petal,

Mississippi:

SECTION 1. Section 14(A) of Ordinance Number 1984(57) as originally adopted on May 17, 1984 is hereby amended to read as follows. To-wit:

SECTION 14: Schedule of rates.

(A). The following schedule of rates is hereby ascertained, found and declared to be reasonable, and the same are established as the rates to be charged for water subject to minimum charges shown below:

RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF PETAL, MISSISSIPPI

WHEREAS, the City of Petal is charged with the duty and responsibility of governing the citizens of the City of Petal, at the least possible expense to its citizens; and

WHEREAS, rates for water and sewer for the City of Petal, as well as surrounding municipalities, have continued to rise above the cost of living and the City of Petal is required to generate sufficient funds to operate the water and sewer system and to retire debt; and

WHEREAS, those citizens of the City of Petal above the age of sixty-five (65) and on fixed incomes, as well as those who are service-connected, totally disabled American veterans who were honorably discharged from military service, suffer from increased financial difficulty in paying as and when due, the City of Petal's imposed charge for water and sewer; and,

WHEREAS, the Mayor and Board of Aldermen wish to be able to amend its ordinances requiring payment for water and sewer service, in order to allow a reduction in water and sewer rates upon presentation of proper proof of eligibility, for those residents who have either reached the age of sixty-five (65) years, or who are service-connected, totally disabled American veterans who were honorably discharged from military service, but is unable to do so without authority of the Mississippi legislature;

NOW, THEREFORE, the Mayor and Board of Aldermen of the City of Petal, Mississippi, resolve and request that the Mississippi legislature permit the City of Petal, through legislation local and private, to establish a separate rate for water and sewer services for those citizens within the City of Petal above the age of sixty-five (65) years and for those citizens who are service-connected, totally disabled American veterans who were honorably discharged from military service.

The above and foregoing Resolution having been presented to the Mayor and Board of Aldermen for approval, Alderman Clayton moved the adoption of the above and foregoing Resolution. Alderman Runnels seconded the motion for adoption of the foregoing resolution.
