RESOLUTION NO. 2018-R-050

A RESOLUTION OF THE CHEROKEE COUNTY BOARD OF COMMISSIONERS TO APPROVE A REQUEST FROM THE BRIDGEMILL COMMUNITY ASSOCIATION FOR A MOTORIZED CART DISTRICT WITHIN THE BRIDGEMILL NEIGHBORHOOD; TO IDENTIFY AUTHORIZED STREETS OF THE MOTORIZED CART DISTRICT WITHIN THE BRIDGEMILL COMMUNITY WHERE MOTORIZED CARTS SHALL BE ALLOWED FOR USE; AND FOR OTHER PURPOSES.

WHEREAS, on or about January 9, 2018, the Cherokee County Board of Commissioners approved Ordinance 2018-O-001 to allow for the use of motorized carts, commonly known as golf carts, to be used in certain areas upon the request of citizens; and

WHEREAS, pursuant to Section 58-10 of the Cherokee County Code of Ordinances, on or about June 4, 2018, a petition was received from the Bridgemill Community Association requesting that the County approve a Motorized Cart District within the Bridgemill community; and

WHEREAS, upon receipt of said petition, notice signs were erected at the neighborhood entrances for a period of thirty (30) days to solicit public comments/feedback; and

WHEREAS, in addition, notice was advertised in the legal organ of Cherokee County to call for a public hearing to be held on said petition; and

WHEREAS, the petition, as well as the area for the proposed Motorized Cart District, has been reviewed by County staff and meets the necessary requirements in place in order for a Motorized Cart District to be granted; and

WHEREAS, a listing of the Authorized Streets that shall be contained within the Motorized Cart District have been attached hereto as Exhibit A; and

WHEREAS, this resolution shall become effective immediately upon its approval by the Cherokee County Board of Commissioners or upon its adoption into law without such approval; and

WHEREAS, the Cherokee County Board of Commissioners hereby grants the Chairman the authority to execute any documents and to take all further actions necessary to carry out the intents and purposes of this Resolution.

NOW, THEREFORE, BE IT RESOLVED by the Cherokee County Board of Commissioners, and it is hereby so resolved by the authority of the same, that the Board of Commissioners hereby approve the petition that has been submitted by the Bridgemill Community Association requesting that the County approve a Motorized Cart District within the Bridgemill Community.

NOW, THEREFORE, BE IT FURTHER RESOLVED by the Cherokee County Board of Commissioners, and it is hereby so resolved by the authority of the same, that the roads/streets listed in the attached Exhibit A shall be designated as Authorized Streets and the use of motorized carts shall be allowed on said Authorized Streets.
