

ORDINANCE NO. 4594

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MESA, ARIZONA AMENDING SECTION 10-3-24 OF THE MESA CITY CODE REGULATING PARKING ON CERTAIN CITY STREET WITHIN THE CITY LIMITS OF MESA; AMENDING SECTIONS 10-4-1, 10-4-2, AND 10-4-4 OF THE MESA CITY CODE PERTAINING TO SPEED LIMITS WITHIN THE CITY LIMITS OF MESA; AND PROVIDING CIVIL SANCTIONS FOR THE VIOLATION THEREOF.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

Section 1: That Section 10-3-24 (D) of the Mesa City Code is amended by changing the following provisions in alphabetical order and thereby not permitting parking on the following street:

NEW HAVEN **FROM A POINT ONE HUNDRED FOURTEEN FEET (114') SOUTH OF BALSAM AVENUE TO A POINT ONE HUNDRED NINETY FEET (190') SOUTH OF BALSAM AVENUE;**

Section 2: That Section 10-4-1 of the Mesa City Code is amended by changing the following provision in alphabetical order and thereby describing streets on which a person shall not exceed a speed of fifty-five (55) miles per hour:

~~Ellsworth Road~~ ~~From Ray Road to Pecos Road;~~

Section 3: That Section 10-4-2 of the Mesa City Code is amended by changing the following provision in alphabetical order and thereby describing streets on which a person shall not exceed a speed of fifty (50) miles per hour:

~~Sossaman Road~~ ~~From Guadalupe Road to Elliot Road;~~

Section 4: That Section 10-4-3 of the Mesa City Code is amended by changing the following provision in alphabetical order and thereby describing streets on which a person shall not exceed a speed of forty-five (45) miles per hour:

Ellsworth Road ~~From McDowell Road to Guadalupe Road~~ **FROM NORTH CITY LIMITS TO SOUTH CITY LIMITS;**


Sossaman Road From **ELLIOT ROAD** ~~Guadalupe Road~~ to the north City limits

Section 5: Civil Traffic Violations: Any violation of or failure or refusal to do or perform any act required by the provisions of this ordinance or of the Mesa City Code as amended herein shall constitute a civil traffic violation.
