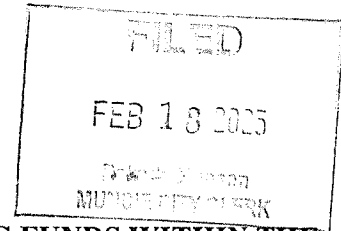


RESOLUTION 60-25



**A RESOLUTION OF THE CITY OF MUNCIE TRANSFERRING FUNDS WITHIN THE
CITY OF MUNCIE COMMON COUNCIL BUDGET**

WHEREAS, the Members of the Common Council of the City of Muncie desire to provide funding to stream meetings and cover other potential costs associated with the newly created Ethics Commission;

WHEREAS, the “Other Services & Charges” line item in the City’s Council’s budget was not funded in either the proposed or approved 2025 budget;

WHEREAS, in order for the City Council to provide funding for the Ethics Commission, funds in the amount of \$3,000.00 need transferred from the “Attorney Fees” line item within the City Council’s budget to the “Other Services & Charges” line item;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL FOR
THE CITY OF MUNCIE, INDIANA:**

- Section 1:** The sum of Three Thousand Dollars (\$3,000.00) is hereby transferred from the City Council Attorney Fees line item (#101-11-431015) to the Other Services & Charges line item (#101-11-439071).
- Section 2:** This Resolution shall be in full force and effect from and after its passage by the Common Council and its approval by the Mayor of the City of Muncie.
- Section 3:** This Resolution shall be in full force and effect from and after its passage.
