Information and Frequently Asked Questions

Q: What is Oregon Business Registry (OBR) number and where can I get one?

A: Any business (other than that of a Sole Proprietor) which operates in the State of Oregon is required to obtain an OBR. Please visit this link to learn more about OBR.

Q: Do I need a business license if I am ONLY selling at the Waldport Wednesday Market?

A: No, if your sales are strictly limited to the Waldport Wednesday Market, you do not need a business license and would be covered under their license.

Q: What qualifies as a Home Based Business:

A: A Home Based Business is one that is operated from the owner's home and does not have a 'brick and mortar" location.

Q: What qualifies as a Mobile Vendor or Food Truck?

A: A Mobile Vendor or Food Truck is one that can be moved and is on wheels, whether in a static location or set up at different locations at different times and does not have indoor space for patrons.

Q: What qualifies as a Itinerant Merchant?

A: A Itinerant Merchant is one who sells goods or wares from a non-permanent business location.
