A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF SUWANNEE COUNTY, FLORIDA, ESTABLISHING A COUNTYWIDE LOCAL MITIGATION STRATEGY WORKING GROUP

**WHEREAS**, the County is undertaking the development of a unified, countywide Local Mitigation Strategy for the County and municipalities within the County in accordance with a contractual services agreement between the County and the Florida Department of Community Affairs:


**RESOLVED FURTHER**, that all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict; and
