**AN ORDINANCE OF THE BOARD OF SUPERVISORS OF THE COUNTY OF DEL NORTE,  
CALIFORNIA TO AMEND, ADD AND ENACT CHANGES TO CHAPTER 20.46 – OFF-  
STREET PARKING OF THE DEL NORTE COUNTY CODE**

The Board of Supervisors of the County of Del Norte do ordain as follows:

**SECTION 1. CODE AMENDMENT.** Section 20.46.020.G of Chapter 20.46 of Title 20, of Del Norte County Code is hereby amended to read as follows:

20.46.020 Space requirements for various uses

G. Dwellings, single-family: two for each dwelling unit;

**SECTION 2. CODE AMENDMENT.** Section 20.46.020.U of Chapter 20.46 of Title 20, of Del Norte County Code is hereby amended to read as follows:

20.46.020

U. Dwellings, multiple, duplexes: one for each studio or one bedroom dwelling unit and two for each dwelling unit with two or more bedrooms.

**SECTION 3. CLASSIFICATION.** This ordinance is considered of a general and permanent nature and is classified as a codified ordinance.

**SECTION 4. SEVERABILITY.** If any part of this Ordinance or its application is deemed invalid by a court of competent jurisdiction, the Board of Supervisors intends that such invalidity will not affect the effectiveness of the remaining provisions or applications and, to this end, the provisions of this Ordinance are severable.


**SECTION 5. EFFECTIVE DATE.** This ordinance shall become effective 30 days following publication of its adoption.




