

ORDINANCE NO. 2014 -005

**BOARD OF SUPERVISORS
COUNTY OF DEL NORTE, STATE OF CALIFORNIA**

**AN ORDINANCE OF THE BOARD OF SUPERVISORS OF THE COUNTY OF DEL NORTE,
CALIFORNIA AMENDING SECTION 20.48.020.B OF THE DEL NORTE COUNTY CODE –
PERMITTING OF PUBLIC USES, QUASIPUBLIC USES, AND UTILITY USES**

The Board of Supervisors of the County of Del Norte do ordain as follows:

SECTION 1. Section 20.48.020 of the of the Del Norte County Code states: "The following uses may be permitted in any district subject to the securing of a use permit in each case."

SECTION 2. – CODE AMENDMENT. Section 20.48.020.B of the Del Norte County Code Chapter 20.48 of Title 20 of the Del Norte County Code is hereby amended as follows:

- B. Public uses, quasipublic uses, or utility provider uses (e.g. water districts, etc.).
Such uses shall only be permitted with the consent of the landowner if the applicant is other than the landowner.

SECTION 3. – CEQA DETERMINATION. The Board of Supervisors finds that this action will not have a significant effect on the environment therefore this ordinance is exempt from CEQA pursuant to the CEQA Guidelines, Section 15061(b)(3).

SECTION 4. CLASSIFICATION. This ordinance is considered of a general and permanent nature and is classified as a codified ordinance.

SECTION 5. SEVERABILITY. If any part of this Ordinance or its application is deemed invalid by a court of competent jurisdiction, the Board of Supervisors intends that such invalidity will not affect the effectiveness of the remaining provisions or applications and, to this end, the provisions of this Ordinance are severable.

SECTION 6. CEQA DETERMINATION. The Board of Supervisors hereby determines that the adoption of this ordinance is exempt from review under the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines section 15061(b)(3) because it does not have the potential for causing significant effect on the environment;

SECTION 7. EFFECTIVE DATE. This ordinance shall become effective 30 days following publication of its adoption.


