**WHEREAS;** Township Cemetery Ordinance Chapter 32 Section 32.09 declares that prices, charges, and other cemetery related fees be set by the Township Board by resolution, and

**WHEREAS;** The Township's primary vendor, West Michigan Burial, has increased prices, and

**WHEREAS;** The Dalton Township Board wishes to set Cemetery prices, charges, and fees

**NOW THEREFORE BE IT RESOLVED** that the Township of Dalton hereby sets prices, charges, and fees, at the Twin Lake Cemetery and Oakland Cemetery, as follows effective upon passage of this Resolution.
