

**ORDINANCE NO. 02-13-01**  
**AN ORDINANCE TO ANNEX**  
**PROPERTY INTO THE CITY OF LANETT**

WHEREAS, on the 4th day of February, 2013, the Chambers County Commission of Chambers County, Alabama has agreed to transfer to the City of Lanett the authority and responsibility to control, supervise, regulate, repair, maintain and improve certain streets, roads, or parts thereof included in the Chambers County Road System. Said transfer is expressly conditioned upon the City of Lanett's acceptance of same by Resolution 02-13-01.

WHEREAS, the Mayor and Council of the City of Lanett do determine that it is in the public interest that said property be annexed to the City of Lanett, and they did further determine that all legal requirements for annexing said real property have been met pursuant to Sections 11-42-20 through 411-42-24, Code of Alabama, 1975.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LANETT, ALABAMA, AS FOLLOWS:

Section 1. The Council of the City of Lanett, Alabama, finds and declares as a legislative body of the city that it is in the best interest of the citizens of the City, and the citizens of the affected area, to bring the territory described in Section 2 of this ordinance into the City of Lanett.

Section 2. The boundary lines of the City of Lanett, Alabama, be and the same are hereby altered or rearranged so as to include all of the territory heretofore encompassed by the corporate limits of the City of Lanett, Alabama, and in addition thereto the following described territory, to-wit:

DESCRIPTION OF PROPERTY SHOWN ON ATTACHED EXHIBIT "A"


Section 3. This Ordinance shall be published as provided by law, and a certified copy of the Petition and of this ordinance shall be filed with the Probate Judge of Chambers County, Alabama.


Section 4. The territory described in this ordinance shall become a part of the corporate limits of Lanett, Alabama upon publication of this ordinance as set forth in Section 3, above.

Further, the territory described in this ordinance shall become a part of District 3, City of Lanett, Alabama.

Chambers County Road System as shown on the attached plat and more particularly described as follows:

County Road 208, State Aid County Project 405-B, including its 70 foot right-of-way and parts thereof beginning at the intersection of the Southerly right-of-way of 13<sup>th</sup> Street Southwest and County Road 208 and thence in a Northerly direction, approximately 4,900 feet, along County Road 208 to the intersection of the Northerly right-of-way Line of 8<sup>th</sup> Street Southwest and County Road 208 and the end of said description.
