

ORDINANCE NO. 02-13-02
AN ORDINANCE TO ANNEX
PROPERTY INTO THE CITY OF LANETT

WHEREAS, on the 14th day of February, 2013, THE OWNERS OF ALL THE REAL PROPERTY, being the owners of all of the real property hereinafter described, did file with the City Clerk a petition asking that the said tracts or parcels of land be annexed and that said lands become a part of the City of Lanett; and

WHEREAS, said petition did contain the signatures of all the owners of the described territory and a map of said property showing the relationship of said property to the corporate limits of the City of Lanett; and

WHEREAS, the Mayor and Council of the City of Lanett do determine that it is in the public interest that said property be annexed to the City of Lanett, and they did further determine that all legal requirements for annexing said real property have been met pursuant to Sections 11-42-20 through 411-42-24, Code of Alabama, 1975.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LANETT, ALABAMA, AS FOLLOWS:

Section 1. The Council of the City of Lanett, Alabama, finds and declares as a legislative body of the city that it is in the best interest of the citizens of the City, and the citizens of the affected area, to bring the territory described in Section 2 of this ordinance into the City of Lanett.

Section 2. The boundary lines of the City of Lanett, Alabama, be and the same are hereby altered or rearranged so as to include all of the territory heretofore encompassed by the corporate limits of the City of Lanett, Alabama, and in addition thereto the following described territory, to-wit:

DESCRIPTION OF PROPERTY SHOWN ON ATTACHED EXHIBIT "A"

Section 3. This Ordinance shall be published as provided by law, and a certified copy of the Petition and of this ordinance shall be filed with the Probate Judge of Chambers County, Alabama.


Section 4. The territory described in this ordinance shall become a part of the corporate limits of Lanett, Alabama upon publication of this ordinance as set forth in Section 3, above.

Further, the territory described in this ordinance shall become a part of District 3, City of Lanett, Alabama.


