

Ordinance No. 1445

**AN ORDINANCE AMENDING THE OFFICIAL
COMPREHENSIVE PLAN
OF THE CITY OF LEBANON**

WHEREAS, the City of Lebanon (the "City") is an Illinois non-home rule Municipal Corporation with the powers and authority granted to it pursuant to the provisions of the City Code of Ordinances, the Illinois Constitution of 1970, and the Illinois Municipal Code, 65 ILCS 5/1-1-1 *et. seq.*; and,

WHEREAS, in 2015, the City adopted the Lebanon Comprehensive Plan, through which actions are outlined and proposed to be undertaken within the City, and within the unincorporated territory within one and one-half miles of the City boundary (the "Extra Territorial Jurisdiction"), as authorized by 65 ILCS 5/11-12-5 *et. seq.* of the Illinois Municipal Code; and,

WHEREAS, the Plan Commission of the City has recommended to the corporate authorities the adoption of proposed amendments (the "Proposed Amendments") to the Lebanon Comprehensive Plan, which Proposed Amendments are attached as Exhibit A hereto and incorporated herein by reference; and,

WHEREAS, the City has received the Plan Commission's recommendation pertaining to the Proposed Amendments within the time provided by law, and pursuant to 65 ILCS 5/11-127; and,

WHEREAS, a legal notice was published on January 23, 2019, in the Lebanon Advertiser, a newspaper of general circulation within the City, giving notice of a Public Hearing on the Proposed Amendments as part of the Lebanon Comprehensive Plan, before the Plan Commission on February 5, 2019; and,

WHEREAS, a Public Hearing was held on February 5, 2019, by the Plan Commission relative to the Proposed Amendments to the Lebanon Comprehensive Plan.

NOW, THEREFORE, be it ordained by the Mayor and City Council as follows:

SECTION 1: ADOPTION OF PROPOSED AMENDMENTS

The Proposed Amendments to the Lebanon Comprehensive Plan, which are attached hereto as Exhibit A and incorporated herein by reference, are hereby adopted as part of the official Comprehensive Plan for the City of Lebanon, St. Clair County, Illinois.

SECTION 2: RECORDING

The City Clerk is hereby authorized and directed to record with the St. Clair County Recorder of Deeds notice of the adoption of the Proposed Amendments to the Lebanon Comprehensive Plan as provided by law and pursuant to 65 ILCS 5/11-12-7 of the Illinois Municipal Code.

SECTION 3: PUBLICATION

The City Clerk is hereby authorized and directed to place the Proposed Amendments to the Lebanon Comprehensive Plan on file and shall make the Proposed Amendments available at all times during the City's business hours for public inspection as provided by law, and pursuant to 65 ILCS 5/11-12-6 of the Illinois Municipal Code.

SECTION 4: GENERAL PROVISIONS

REPEALER: All ordinances or portions thereof in conflict with this Ordinance are hereby repealed.

SEVERABILITY: Should any provision of this Ordinance be declared invalid by a court of competent jurisdiction, the remaining provisions will remain in full force and effect, the same as if the invalid provision had not been a part of this Ordinance.

EFFECTIVE DATE: This Ordinance shall be in full force and effect from and after its passage and approval as required by law, but in no event earlier than ten (10) days after filing of a notice of its adoption with the St. Clair County Recorder of Deeds.

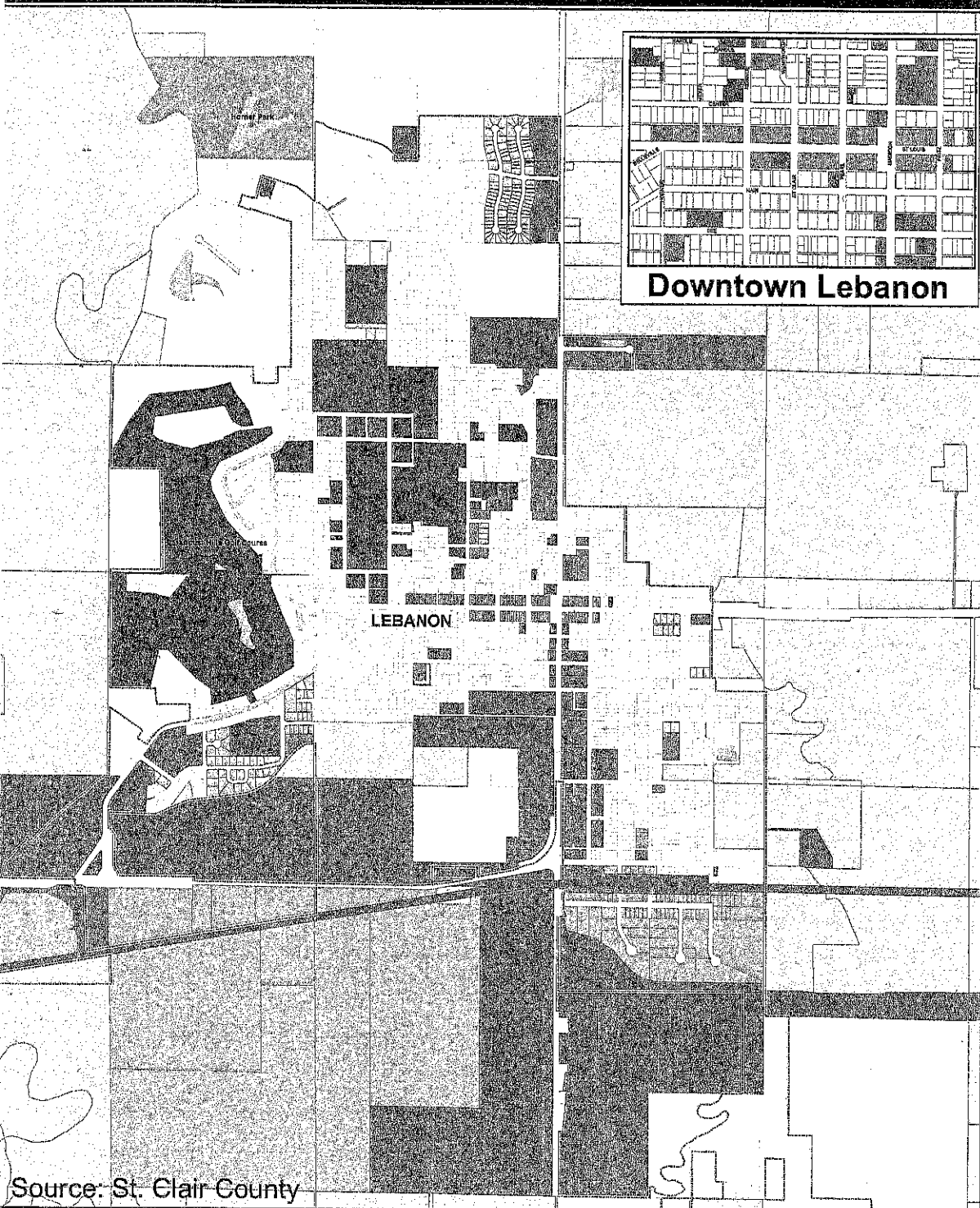
