

ORDINANCE NO. 1455

A SECOND ORDINANCE GRANTING  
A SPECIAL USE PERMIT TO TABITHA BENNETT  
TO OPERATE A BAKERY  
IN THE "MH-1" MANUFACTURED HOME RESIDENTIAL DISTRICT  
AT 802 PLUM STREET

WHEREAS, the City Council adopted Ordinance Number 1435 ("An Ordinance Granting a Special Use Permit to Tabitha Bennett to Operate a Bakery in the 'MH-1' Manufactured Home Residential District at 802 Plum Street") on October 8, 2018;

WHEREAS, after the adoption of Ordinance Number 1435 ("An Ordinance Granting a Special Use Permit to Tabitha Bennett to Operate a Bakery in the 'MH-1' Manufactured Home Residential District at 802 Plum Street"), the City Council became aware that – in view of the requirements of Section 36-43 of the Lebanon City Code – the granting of the special use permit to Tabitha Bennett had been premature because Section 36-174 (defining the special uses permitted in the 'MH-1' Manufactured Home Residential District) of the Lebanon City Code had not yet been amended to include a bakery as a permitted special use;

WHEREAS, the City Council adopted Ordinance Number 1450 ("Amending Section 36-174 of the Lebanon City Code to Designate Bakeries as an Additional Special Use Allowed in the MH-1 Manufactured Home Residential District") on April 8, 2019;

WHEREAS, the Plan Commission, after holding another hearing on this matter, again recommended to the City Council the granting of a special use permit to Tabitha Bennett to operate – as a special use within the 'MH-1' Manufactured Home Residential District – a bakery at 802 Plum Street;

WHEREAS, the City Council has made the findings of fact, and the statement of its reasons for granting the Petition for Special Use Permit in question, in a separate resolution numbered as 4-2019;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LEBANON, AS FOLLOWS:

*Section 1.* Tabitha Bennett, 802 Plum Street, Lebanon, Illinois 62254, is hereby granted a Special Use Permit in an "MH-1" Manufactured Home Residential District, as defined in Division 4 (Sections 36-153 through 36-174) of Article II of Chapter 36 of the *Lebanon City Code*, to operate a bakery in the residence in the "MH-1" Manufactured Home Residential District, at 802 Plum Street, Lebanon, Illinois, upon the conditions set forth in Section 2 below.

*Section 2.* The Special Use Permit is granted with four conditions: namely,

- (a) There shall be no signage or alteration of the dwelling;

- (b) All bakery goods produced will be taken off the location to be delivered or sold elsewhere;
- (c) No patrons of the business shall stop by the dwelling, and, so, no parking requirements are imposed; and,
- (d) Tabitha Bennett – who has all the necessary food certifications required by the State of Illinois – shall maintain those food certifications;

*Section 3.* This ordinance shall be known as Ordinance No. 1455 .


*Section 4.* This ordinance shall be in full force and effect from and after its passage and approval in accordance with law.
