AN ORDINANCE TO PROVIDE FOR THE DISPOSITION BY CONVEYANCE OF PROPERTY LOCATED ALONG RIVERVIEW ROAD, ROCK HILL, SOUTH CAROLINA, BY THE CITY OF ROCK HILL TO YORK COUNTY

BE IT ORDAINED by the Governing Body of the City of Rock Hill, in Council assembled:

SECTION 1. That this Ordinance is being adopted in order to effect proper compliance with the provisions of the Home Rule Act of 1975, now South Carolina Code of Laws for 1976, Section 5-7-30, Section 5-7-40 and Section 5-7-260, and Section 2-48 and Section 2-96 of the Code of the City of Rock Hill.

SECTION 2. That the City of Rock Hill, South Carolina, is the owner of property located on Riverview Road, containing 0.005 acre, and bearing tax parcel number 662-07-01-028, in the City of Rock Hill, York County, South Carolina; that the City of Rock Hill has agreed to convey to York County such tract described on Exhibit A to the Title to Real Estate attached hereto and made a part hereof for and in consideration of One Hundred and 00/100 Dollars (\$100.00) provided the City retains an electric utility easement located at the rear of the property and its rights to install, operate, maintain, repair and replace public utilities within the area being conveyed.

SECTION 3. That conveyance to York County of the above referenced tract for the consideration set forth above, which shall be in

accordance with normal City of Rock Hill policies, documentation and procedures, with the final form of the above described conveyance approved by the City Attorney, is hereby approved, authorized, directed, ratified and confirmed in all respects.

<u>SECTION 4.</u> That all ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION 5. That this Ordinance shall be and become finally binding immediately after same shall have received first and final readings, given in manner required by law.
