AN ORDINANCE OF THE CITY OF SWEETWATER FLORIDA RELEASING DECLARATION OF RESTRICTIONS RECORDED IN OR BOOK 27126 PAGES 3955-3964, DECLARATION OF RESTRICTIONS OR BOOK 32707 PAGES 1519-1524, EASEMENT AND OPERATING COVENANT / GRANT OF CROSS ACCESS OR BOOK 27328 PAGES 4912-4918 AND A UNITY OF TITLE OR BOOK 27328 PAGES 4850-4853 AS THEY APPLY TO CERTAIN PROPERTY AS DESCRIBED IN EXIBIT A; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; PROVIDING FOR EFFECTIVE DATE.

WHEREAS, CREI Holdings, LLC (the "Owner") owns the property described in Exhibit A; and

WHEREAS, the Owner is requesting to release certain declaration of restrictions, covenants and unity of title running with the property described in Exhibit A (the "Property"); and

WHEREAS, the Owner of the Property, shall provide a site plan unifying the entire property as one development: and

WHEREAS, the Owner will provide a new covenant and unity of title unifying all the current and proposed development on the Property as shown in Exhibit B; and

WHEREAS, the Mayor and City Commission find that this ordinance serves the best interest of the businesses in City of Sweetwater.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COMMISSION OF THE CITY OF SWEETWATER, FLORIDA AS FOLLOWS:

- Section 1. That the recitals and findings contained in the Preamble to this Ordinance are adopted by reference and incorporated as if fully set forth in this Section.
- Section 2. That the Declaration of Restriction recorded in OR BOOK 27126 Pages 3955-3964 and OR BOOK 32707 Pages 1519-1524, Easement and Operating Covenant OR BOOK 27328 Pages 4912-4918 and Unity of Title OR BOOK 27328 Pages 4850-4853 are hereby released from the property described in Exhibit A.
- Section 3. That the property owner provides a new covenant and unity of title unifying the property and the developments as shown in Exhibit B.
- Section 4. That all ordinances or portions of the City Land Development Code in conflict with the provisions of this Ordinance shall be repealed upon the effect hereof.
- Section 5. That if any section, clause, sentence, or phrase of this Ordinance is for any reason held invalid or unconstitutional by a court of competent jurisdiction, the holding shall not affect the validity of the remaining portions of this Ordinance.
- Section 6. That this Ordinance shall become effective upon its adoption by the City Commission and approval by the Mayor or if vetoed upon its reenactment by the City Commission as provided by the Charter of the City of Sweetwater.
