OF OF THE CITY AN **ORDINANCE** FLORIDA, RELATIED TO SWEETWATER, ZONING, MODIFYING DEFINITIONS IN SECTION 33-1 (DEFINITIONS) OF THE CODE OF MIAMI-DADE COUNTY, FLORIDA, AS APPLICABLE TO THE CITY OF SWEETWATER; ADDING TO THE LIST OF PERMITTED USES IN SECTION 33-259 (IU-1, INDUSTRIAL LIGHT MANUFACTURING DISTRICT) OF THE CODE OF MIAMI-DADE COUNTY, FLORIDA, AS APPLICABLE TO THE CITY OF SWEETWATER; PROVIDING FOR SEVERABILITY; **PROVIDING PROVIDING** FOR AN CODIFICATION: AND EFFECTIVE DATE.

WHEREAS, on December 14, 2010, qualified electors approved the annexation of certain adjoining lands (the "Annexed Area") into the City of Sweetwater (the "City"); and

WHEREAS, on December 22, 2010, the Mayor and Commission of the City adopted Ordinance No. 3519, maintaining the Miami-Dade County Comprehensive Development Master Plan designations and the Miami-Dade County zoning district and map designations on the Annexed Area, and establishing a process for future zoning and land use applications; and

WHEREAS, the Miami-Dade County Code currently defines and lists the approved uses in the zoning districts where the Annexed Area is located; and

WHEREAS, the City Commission wishes to add "Furniture Merchandise Mart" to the list of allowed uses in the IU-I (Industrial, Light Manufacturing District); and

WHEREAS, the City Commission finds that the enactment of this Ordinance is necessary so as to protect the public health, safety and welfare of the residents of the City.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COMMISSION OF THE CITY OF SWEETWATER, FLORIDA AS FOLLOWS:

Article 1. Ordinance number 3519 is hereby amended by adding the following underscored text to the Miami-Dade County Comprehensive Development Master Plan designations and the Miami-Dade County zoning district and map designations applicable in the Annexed Area:

Section 33-1. Definitions.

For the purposes of this chapter, the following definitions for terms used herein shall apply to all sections of this chapter unless the context clearly indicates otherwise:

(46.2) Furniture merchandise mart. A structure or series of structures consisting of a minimum floor area of 250,000 square feet on one (1) contiguous property, displaying, offering for sale and selling home and office furniture, accessories, furnishings, equipment and related merchandise to the public, including, without limitation, showroom, warehouse and storage and which use or operation may offer or furnish other accessory uses and supportive services to its patrons, employees and otherwise to the public including, without limitation, restaurant and/or food service for on or off premises consumption, supervised children play areas, food market and sale of food and beverages for on or off premises consumption.

Section 33-259. Uses permitted.

No land, body of water or structure shall be used or permitted to be used and no structure shall be erected, constructed, moved or reconstructed, structurally altered, or maintained, which is designed, arranged or intended to be used or occupied for any purpose, unless otherwise provided herein, in IU-I District, excepting for one (1) or more of the following:

(34.1) Furniture merchandise mart, as defined in Section 33-1 (46.2) of this Code. Furniture merchandise marts may, but are not required, to include the manufacture or assembly of the products being sold or offered for sale to the public. Furniture merchandise marts shall not be subject to the limitations of retail sales area provided in Section 33-259(69).

Article 2. All ordinances or portions of the Code of Ordinances of the City of Sweetwater in conflict with the provisions of this ordinance shall be repealed upon the effective date hereof.

Article 3. It is the intention of the Mayor and the City Commission that the provisions of this ordinance be incorporated into the Code of Ordinances; to effect such intention codifiers may change the words "ordinance" or "section" to other appropriate words.

Article 4. If any portion of this ordinance is held invalid by a court of competent jurisdiction, such invalidity shall not affect the remaining portions of the ordinance.

Article 5. This ordinance shall become effective upon its adoption by the City Commission and approval by the Mayor or, if vetoed, upon its reenactment by the City Commission as provided by the Charter of the City of Sweetwater.
