

Ordinance No. 2014- 13

An ordinance amending Section 24-86 of Victoria City Code, relating to Fees for Special Events, to add fees for parade permitting, barricade rental, and staff set-up, repealing conflicting parts of existing ordinances, providing for codification and savings, and declaring an effective date.

Whereas in order to correct inconsistencies in the practices of City barricade use by private groups for parades, this ordinance establishes set fees and a price structure for parades and barricade use;

Now therefore, be it ordained by the City Council of the City of Victoria, Texas:

1. That the following section of Chapter 24 of the Victoria City Code is hereby amended to read as follows:

Sec. 24-86. Special events.

The Director of the Department of Parks and Recreation may establish fees for additional special events/programs with approval of City Manager.

Special events area of Riverside Park

Event - with electricity and/or water, per day\$150.00

Special Event Area deposit\$250.00

Special Events Mobile Stage\$600.00

Ball fields

Riverside Stadium\$225/game

Lowe Field\$75/game

Rippamonti Field\$75/game

Rippamonti and Lowe Fields (Tournaments)\$150/day

Recreation Programs

Market Days booths

Regular booth\$25.00

Regular booth with electricity\$30.00

Large booth\$35.00

Large booth with electricity\$40.00

BootFest

Arts and Crafts Booths\$100.00

Food Vendors Booths\$300.00

The Director of Parks and Recreation may establish fees for associated items with the approval of the City Manager.

Electrical distribution system (four blocks around DeLeon Plaza)

\$175.00/block

No refunds once the equipment is installed.

Parade Permit Fee\$25.00

Barricade Use (user set-up and removal)\$50.00

Deposit\$250.00*

Damaged or lost barricade feecurrent replacement value

Set-up by City Staff\$500.00

* In the event of lost or damaged barricades, the Parks Department will withhold the amount of replacing the damaged or lost barricade equal to the cost of a replacement barricade from the deposit. In the event that the total cost to replace multiple barricades exceeds the deposit amount, customer will be billed any additional charges.

2. All parts of ordinances in conflict with this ordinance are repealed to the extent of such conflict.

3. If any provision of this ordinance, or the application thereof to any person or circumstances, shall be held invalid or unconstitutional by a Court of competent jurisdiction, such invalidity shall not affect the other provisions, or application thereof, of this ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared to be severable.

4. It is the intention of the City Council that this ordinance shall become a part of the Code of the City of Victoria, Texas, and it may be renumbered and codified therein accordingly, in the manner approved by the City Attorney. The Code of the City of Victoria, Texas, as amended, shall remain in full force and effect, save and except as amended by this ordinance.

5. This ordinance shall become effective 10 days after final passage and approval by the City Council of the City of Victoria, Texas.




