

## **ORDINANCE NO. 2013-26**

AN ORDINANCE AMENDING THE DEFINITION OF *FIXED BASE OPERATOR* IN SECTION 3.3-1, DEFINITIONS, OF ARTICLE 1, IN GENERAL, OF CHAPTER 3.3, AIRCRAFT AND AIRPORT; AND AMENDING DIVISION 2, FIXED BASE OPERATOR AND GENERAL AIRPORT TENANT CATEGORIES, OF ARTICLE IV, COMMERCIAL OPERATIONS, OF CHAPTER 3.3, AIRCRAFT AND AIRPORT, OF THE *CODE OF ORDINANCES*, BY ADDING A NEW SECTION 3.3-65.2, SPECIALIZED AVIATION SERVICE OPERATION; REPEALING ALL INCONSISTENT ORDINANCES OR PARTS THEREOF; AND SETTING FORTH AN EFFECTIVE DATE.

**BE IT ENACTED BY THE PEOPLE OF THE CITY OF ORMOND BEACH, FLORIDA, THAT:**

**SECTION ONE.** The definition of *Fixed base operator* in Section 3.3-1, Definitions, of Article 1, In General, of Chapter 3.3, Aircraft and Airport, of the City of Ormond Beach, Florida *Code of Ordinances* is hereby amended to read:

**Sec. 3.3-1. Definitions.**

*Fixed base operator* means any person performing any of the functions or furnishing any of the services, as set forth in this chapter, for "fixed base operators" at the airport; the categories of "fixed based operator" shall be as follows:

*Category 1* shall include the sale of aviation fuel and oil, facilities for tiedown or other storage of aircraft, ramp services and some capability for minor flight line repairs.

*Category 2* shall include flight instruction and aircraft rental.

*Category 3* shall include air taxi and charter operations.

*Category 4* shall include aircraft sales.

*Category 5* shall include aircraft, engine, propeller and accessories maintenance.

*Category 6* shall include radio and instrument repair service.

*Category 7* shall include airship operations.

*Category 8* shall include Specialized Aviation Service Operation.

**SECTION TWO.** Division 2, Fixed Base Operator and General Airport Tenant Categories, of Article IV, Commercial Operations, of Chapter 3.3, Aircraft and Airport, of the City of Ormond Beach, Florida, *Code of Ordinances* is hereby amended by adding the following section which shall read as follows:

**Sec. 3.3-65.2. Category 8: Specialized aviation service operation (SASO).**

Specialized Aviation Service Operations (SASOs), also known as single service operators or special fixed base operators, are persons or entities providing a single or limited number of commercial aeronautical activities or specialized commercial flight support services. Fixed base operators in this category shall:

- (1) Lease or provide, under terms acceptable to the city for this exclusive use, a facility located on the airport of appropriate size to accommodate the services being offered, be accessible to the flying public, and be marked with appropriate signage;
- (2) Employ personnel properly certified by the Federal Aviation Administration to provide and support the types of services and activities which will be offered under this category;
- (3) Make provisions to have appropriate personnel in attendance at the facility at all times during posted business hours. An operator who does not have posted business hours shall provide for adequate means of contacting the operator to arrange for appointments and must agree to contact potential customers within 24 hours of the original inquiry for service;
- (4) Provide to the Airport Manager and keep current a written statement of names, addresses, and contact information for all personnel responsible for the operation and management of the SASO.

**SECTION THREE.** All Ordinances or parts of Ordinances in conflict herewith are hereby repealed, to the extent of such conflict.

**SECTION FOUR.** This Ordinance shall take effect immediately upon its adoption.
