

ORDINANCE NO. 154 OF 2024

AN ORDINANCE TO REVISE CHAPTER 74 SOLID WASTE, ARTICLE III "REGULATIONS" SEC 74-54 OF THE CITY OF SHREVEPORT, LOUISIANA, CODE OF ORDINANCES, RELATIVE TO THE DISPOSAL FEE PER TON OF NORMAL WASTE, AND TO OTHERWISE PROVIDE WITH RESPECT THERETO.

BY COUNCILMEMBER: GREEN

WHEREAS, the Shreveport City Code Chapter 74, Article III titled "Regulations" Sec 74-54 is in need of revision with regard to disposal fees for city owned facilities; and

WHEREAS, it is recommended that the City revise its ordinance so as to adjust for the changes in the Cost Price Index.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Shreveport, Louisiana, in due, legal and regular session convened, that Chapter 74, Article III, Sec 74-54 of the City of Shreveport, Louisiana, Code of Ordinances shall be modified as follows:

(3) The fee per ton shall be \$44.03, with any partial fee being prorated on the basis of that basic fee exclusive of the minimum fee requirement.

BE IT FURTHER ORDAINED this Article shall be effective January 1, 2025.



BE IT FURTHER ORDAINED that all Ordinances or parts thereof in conflict herewith are hereby repealed.

BE IT FURTHER ORDAINED that this Ordinance shall become effective in accordance with the provisions of Shreveport City Charter Section 4.23.



PURPOSE
To revise Chapter 74, Article III of the Shreveport City Code relative to the disposal fee associated with normal waste per ton.

BACKGROUND INFORMATION
The City contracts with Republic Services, Inc./Allied Waste (BFI) to operate the Woolworth Landfill. The contract allows them to increase their annual fee, based on the CPI, with a max increase of 6%. They have notified the City that the 2025 increase will be \$0.77 more per ton. This ordinance increases the City’s gate fee from \$43.26 to \$44.03 per ton, effective 01/01/2025. Please note that the Republic (BFI) charge applies to all waste entering the landfill, which includes what enters on City garbage trucks.
