ORDINANCE NO. 22—O—82

**AN ORDINANCE AMENDING VARIOUS SECTIONS OF CHAPTER 14
OF THE CITY CODE REGARDING MOBILE FOOD VENDORS**

WHEREAS, the City is an Illinois home rule municipality; and

WHEREAS, Chapter 14 of the Code of Ordinances, City of Waukegan, Illinois (“*City Code*”) establishes regulations regarding licenses and miscellaneous business regulations; and

WHEREAS, the Mayor and City Council have determined that it will serve and be in the best interests of the City and its residents to amend the City Code;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF WAUKEGAN, ILLINOIS, AS FOLLOWS:

SECTION 1. RECITALS. The foregoing recitals are incorporated into, and made a part of, this Ordinance as the findings of the Mayor and City Council.

SECTION 2. AMENDMENTS TO SECTION 14-484 OF CITY CODE. Section 14-484, titled “General requirements”, of Chapter 14, titled “Licenses and Miscellaneous Business Regulations”, of the City Code, is hereby amended to read as follows: (additions are in **bold underline** and deletions are ~~struck through~~)

“Sec. 14-484. - General requirements.

(a) — ~~A maximum of ten mobile food vendor licenses shall be issued by the city at any given time. If a license is issued to an applicant who fails to commence operation of a mobile food dispensing unit within 60 days of the license issuance, the license shall revert to the city, upon notice to the licensee.~~

(b)(a) Licensed mobile food dispensing units shall be permitted to park/place and operate their business only in limited authorized locations, and only at authorized times. Current authorized locations and times are as follows:

Clayton Street between County Street and Genesee Street, every Friday from 8:00 a.m. to 10:00 p.m.

Clayton Street between County Street and Genesee Street, third Saturday of each month during ArtWauk, from 5:00 p.m. to 10:00 p.m.

Clayton Street between County Street and Genesee Street, on nights when a ticketed event is being held at the Genesee Theatre, from two hours before the event to one hour after the event.

Stiner Pavilion Concert Grounds, during times when the area is designated as a Festival Zone for summer concerts.

Waukegan Municipal Beach, ~~every Friday, Saturday and Sunday,~~ **7 days a week, 8:00 a.m. to 8:00 p.m, subject to a vendor agreement with the City of Waukegan.**

Memorial Day, 4th of July and Labor Day at the above times and locations.

600 Lakehurst Road and 4001-4011 Fountain Square Place during times when a casino is operating and open to the public.

- ~~(e)~~**(b)** Consumers shall, where applicable, be provided with single service articles, such as plastic forks and paper plates, and a waste container for their disposal. All mobile food dispensing units shall offer a waste container for public use that the operator shall empty at his own expense.
- ~~(d)~~**(c)** No mobile food dispensing unit shall be parked on the street overnight, or left unattended, and unsecured at any time. Any mobile food dispensing unit which is found to be unattended shall be considered a public safety hazard and may be ticketed and removed at the discretion of the chief of police.
- ~~(e)~~**(d)** Mobile food vendor licenses are not transferrable.
- ~~(f)~~**(e)** All signage, product and menu information must be securely attached to the mobile food vehicle.
- ~~(g)~~**(f)** The City of Waukegan mobile food vendor license issued pursuant to the terms of this division shall be posted conspicuously in that part of the vehicle so that it is visible to the public by sight.

SECTION 3. EFFECTIVE DATE. This Ordinance shall take effect and be in effect ten days after passage and publication according to law.
