ORDINANCE 23—O—349

**AN ORDINANCE INCREASING THE NUMBER OF
F-1 PACKAGE BEER, WINE & GASOLINE SALES
LIQUOR LICENSES BY ONE
ST. LOUIS FOOD MART INC. DBA LEWIS AND SUNSET BP
2201 N. LEWIS AVE**

WHEREAS, Chapter 3 of the Code of Ordinances of the City of Waukegan (1992) as amended ("**City Code**") sets forth regulations for the sale and consumption of alcoholic beverages in the City of Waukegan ("**Liquor Control Ordinance**"); and

WHEREAS, the Liquor Control Ordinance establishes classes of licenses required to be obtained and maintained by any business seeking to engage in the sale of alcoholic liquor; and

WHEREAS, pursuant to Section 3-14 of the Liquor Control Ordinance, the City Council has the sole authority to create classes of liquor licenses and set the number of available licenses within each class; and

WHEREAS, the Local Liquor Commissioner may not issue a local liquor license in a class that is in excess of the number authorized by the City Council; and

WHEREAS, the City has been petitioned by St. Louis Food Mart inc. DBA Lewis and Sunset BP ("Petitioner"), to issue a Class F-1 Package Beer, Wine & Gasoline Sales liquor license to the premises located at 2201 N Lewis Ave, within the corporate limits of the City of Waukegan; and

WHEREAS, City staff and the Local Liquor Commissioner have reviewed the Petitioner's request and application for a Class F-1 Package Beer, Wine & Gasoline Sales liquor license for the Premises ("**Application**") and has determined that it is complete, and the issuance of a license for the Premises will not violate the Liquor Control Ordinance or the Illinois Liquor Control Act of 1934 (235 ILCS 5/1-1 *et seq.*); and

WHEREAS, the City Council wishes to expand business opportunities wherever possible, for the overall benefit of the citizens and taxpayers of this City; and

WHEREAS, taking into consideration the foregoing, the City Council has determined that increasing the number of available Class F-1 Package Beer, Wine & Gasoline Sales liquor license by one is appropriate;

NOW THEREFORE, IN EXERCISE OF ITS HOME RULE POWERS, BE IT ORDAINED BY THE CITY OF WAUKEGAN, ILLINOIS AS FOLLOWS:

SECTION ONE. The City's Licensing Department, acting as the Secretary of the Local Liquor Commissioner, is directed to revise the chart of available liquor licenses, within Chapter 3 of the City Code, to increase the number of Class F-1 Package Beer, Wine & Gasoline Sales liquor licenses by one (1).

SECTION TWO. This Ordinance will be in full force and effect from and after its passage, approval and publication as required by law and the submission by the Petitioner of all required documentation and fees for a Class F-1 Package Beer, Wine & Gasoline Sales liquor license.


SECTION THREE. As set forth in Subsection 3-14(a)(4) of the Liquor Control Ordinance, in the event that the Petitioner's license for the Premises is forfeited, voided, or revoked for any reason, the number of available Class F-1 Package Beer, Wine & Gasoline Sales liquor licenses will immediately, and with no further action of the City Council, be reduced by one (1).
