**AN ORDINANCE REDUCING THE PENALTY FOR A RENTAL LICENSE LATE FEE  
OR BUSINESS LICENSE LATE FEE**

**NOW THEREFORE, IN EXERCISE OF ITS HOME RULE POWERS, THE CITY  
COUNCIL OF THE CITY OF WAUKEGAN, LAKE COUNTY ILLINOIS HEREBY  
ORDAINS AS FOLLOWS:**

**SECTION ONE.**

Section 14-1101 of the City of Waukegan, Illinois Code of Ordinances is hereby amended by adjusting the table entry for “Rental License and/or Inspection Late Fee” to set the fee at “Additional 10% of underlying fee”

**SECTION TWO.**


Section 14-1101 of the City of Waukegan, Illinois Code of Ordinances is hereby amended by adding a the table entry for “Business License Late Fee (30 days past due date)” and to set the fee at “Additional 10% of underlying fee”; and by striking the paragraph following the table which currently reads “All business license fees not paid within 30 days of the due date shall incur an additional late fee charge equal to 50 percent of the business license fee.”

**SECTION THREE.**

This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
