**AN ORDINANCE ADDING ONE CLASS E RESTAURANT LIQUOR LICENSE
FOR JACK'S PIZZA AND BURGERS**

WHEREAS, the City Council has been petitioned by 31 North Corp., doing business as “Jack’s Pizza and Burgers” for a Class E Restaurant liquor license for its establishment located at 1000 N Green Bay Road, within the corporate limits of the City of Waukegan; and

WHEREAS, the City Council has considered the application, and has determined that the proposal is appropriate for the suggested location and type of business, and it is an appropriate designated licensee, and


WHEREAS, the City Council wishes to expand business opportunities wherever possible, for the overall benefit of the citizens and taxpayers of this City,

**NOW THEREFORE, IN EXERCISE OF ITS HOME RULE POWERS, BE IT
ORDAINED BY THE CITY OF WAUKEGAN, ILLINOIS AS FOLLOWS:**


SECTION ONE. The City Clerk, acting as the Secretary of the Local Liquor Commissioner is directed to revise the chart of allowed liquor licenses, within Chapter 3 of the City Code, to increase the number of Class E (restaurant) liquor licenses by one (1), effective at such time as the business known as Jack’s Pizza and Burgers, located at 1000 N. Green Bay Road, within the Corporate Limits of the City of Waukegan has been issued all necessary permits, successfully completed the required background checks, and further that it has qualified for a City of Waukegan Liquor License.

SECTION TWO.

This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
