ORDINANCE NO. 23-051

AN ORDINANCE OF THE CITY OF GALVESTON, TEXAS, AMENDING CHAPTER 34, "TRAFFIC", SECTION 34-110, "PARKING TOTALLY PROHIBITED" OF "THE CODE OF THE CITY OF GALVESTON 1982", AS AMENDED, BY ADDING THE "EAST SIDE OF SAN JACINTO BETWEEN FM 3005 AND ZACHARY; MAKING VARIOUS FINDINGS AND PROVISIONS RELATED TO THE SUBJECT; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, a request for modification of parking regulations for the area located from the East Side of San Jacinto between FM 3005 and Zachary was received. As the area has become increasingly congested there are safety concerns with having parking availability on both sides; and,

WHEREAS, Staff is requesting to add the east side of San Jacinto between FM 3005 and Zachary to the parking totally prohibited regulations; and,

WHEREAS, the City Council of the City of Galveston, Texas, deems it in the public interest to amend Chapter 34, "Traffic" as provided below.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GALVESTON, TEXAS:

SECTION 1. The findings and recitations set out in the preamble to this Ordinance are found to be true and correct and they are hereby adopted by the City Council and made a part hereof for all purposes.

SECTION 2. Section 34-110, "Parking totally prohibited" is amended to read and provide as follows:

Sec. 34-110. - Parking totally prohibited.

When signs and/or curb markings have been installed giving notice thereof, no person shall at any time, park a vehicle upon any of the following streets:

(1) Tremont Street between The Strand and the alley north of The Strand, on the west side.

- (26) East side of Holiday Drive, also known as 4th Street, between Barracuda Avenue and Harborside Drive.
- (27) Reserved. East side of San Jacinto between FM 3005 and Zachary:
- (28) Stewart Road from one hundred fifty (150) feet east of the east right-of-way line of Pine Drive to two hundred (200) feet west of the west right-of-way line of Pine Drive, on the north side;

SECTION 3. It is hereby declared to be the intention of the City Council that the sections, paragraphs, sentences, clauses, and phrases of this Ordinance are severable and, if any phrase,

clause, sentence, paragraph or section of this Ordinance should be declared invalid by the final judgment or decree of any court of competent jurisdiction, such invalidity shall not affect any of the remaining phrases, clauses, sentences, paragraphs, and sections of this Ordinance.

SECTION 4. All Ordinances or parts thereof in conflict herewith are repealed to the extent of such conflict only.

SECTION 5. All Ordinances of general and permanent nature, and amendments to such Ordinances, hereinafter adopted by the City Council, shall be drafted, so far as possible, as specific amendments of, or additions to, this Code. Amendments to this Code are intended for publication to the Galveston City Code. The Codifier is authorized pursuant to the Galveston City Code to make non-substantive changes to the Ordinance prior to publishing.

SECTION 6. In accordance with the provisions of Sections 12 and 13 of Article II of the City Charter this Ordinance has been publicly available in the office of the City Secretary for not less than 72 hours prior to its adoption; that this Ordinance may be read and published by descriptive caption only.

SECTION 7. This Ordinance shall be and become effective upon its adoption and publication in accordance with the provisions of the Charter of the City of Galveston.
