ORDINANCE NO. 2016-14, AS AMENDED

AN ORDINANCE AMENDING APPENDIX C TRAFFIC ORDINANCES OF THE CODE OF ORDINANCES OF THE TOWN OF WEST WARWICK.

WHEREAS: The Town Council of the Town of West Warwick on the 16th day of August, 2016, enacted Ordinance Number 2016 – 10, as amended, which ordinance did codify Appendix C, TRAFFIC ORDINANCES, of the Code of Ordinances of the Town of West Warwick as an ordinance, and

WHEREAS: Said Ordinance 2016 – 10, as amended, provided that Appendix C shall from time to time be amended by the addition or deletion of traffic ordinances, and

WHEREAS: Said Ordinance 2016 – 10, as amended, further provided for the establishment of a Traffic Committee, which committee shall report to the Town Council regarding the addition or deletion of traffic ordinances, and

WHEREAS: The Traffic Committee has made such a recommendation to the Town Council regarding the addition or deletion of a traffic ordinance, which report has been filed with the Town Council, and

WHEREAS: Notice having been given by the Traffic Committee to all persons affected by said amendments, and

WHEREAS: Said amendments shall not take effect until 10 days after the erection of a traffic control device

NOW, THEREFORE, IT IS HEREBY ORDAINED that the Town Council of the Town of West Warwick hereby amends Appendix C, Traffic Ordinances as follows:
