Ordinance amending the Traffic Ordinance of the City of White Plains in relation to adding a "No Parking" zone on Gedney Way, modifying a "No Parking" Zone on Harding Avenue, adding a Stop Sign on Greenridge Avenue at Livingston Avenue and deleting the section of "Through Highway" on Greenridge Avenue at Livingston Avenue.

AN ORDINANCE AMENDING THE TRAFFIC ORDINANCE OF THE CITY OF WHITE PLAINS IN RELATION TO ADDING A “NO PARKING” ZONE ON GEDNEY WAY, AND MODIFYING A “NO PARKING” ZONE ON HARDING AVENUE, ADDING A STOP SIGN ON GREENRIDGE AVENUE AT LIVINGSTON AVENUE AND DELETING THE SECTION OF “THROUGH HIGHWAY” ON GREENRIDGE AVENUE AT LIVINGSTON AVENUE

The Common Council of the City of White Plains hereby ordains and enacts as follows:

Section 1. Sec 303-a of Article III of said ordinance adopted by the Common Council of the City of White Plains on the 3rd day of September, 1946 entitled, “An Ordinance Regulating Traffic in the City of White Plains and Providing Penalties for Violations of its Provisions,” as last amended on the 2nd day of January 2024 is hereby amended to create the following section:

STOP INTERSECTIONS

54-c GREENRIDGE AVENUE AT LIVINGSTON AVENUE:

Stop signs on Greenridge Avenue facing northbound and southbound traffic. Stop signs on Livingston Avenue facing eastbound and westbound traffic.

Section 2. Section 202 of Article II as last amended on the 6th day of March, 2023 hereby amended to read as following:

NO PARKING

65-a Gedney Way, on the southside, between the driveways to the Gedney Way Recycling Facility and the City of White Plains Recreation and Parks Department, a distance of approximately 30 feet .

77. Harding Avenue, on the westerly side, between Battle Avenue and Chatterton Avenue, on the easterly side between Central Avenue and Robertson Avenue, and on the easterly side a distance of 120 feet southerly from a point 255 south of the southerly curb line of Chatterton Avenue, and on the east side a distance of 50 feet northerly from a point 150 feet north of the Battle Avenue northerly curb line.

Section 3. Sec 303 as last amended on 2ND day of December, 1996 is hereby amended to delete the following location:

THROUGH HIGHWAYS

10 GREENRIDGE AVENUE: STOP SIGNS AT:

- Bolton avenue- facing eastbound and westbound traffic
- Doyer Avenue- facing eastbound and westbound traffic
- Linda Avenue- facing eastbound and westbound traffic
- ~~Livingston Avenue- facing eastbound and westbound traffic~~
- Prescott Avenue- facing westbound traffic
- Rutherford Street- facing eastbound and westbound traffic
- Stratford Street- facing eastbound and westbound traffic

Section 4. This ordinance shall take effect immediately.
