ORDINANCE NO. 21-O-0005

AN ORDINANCE AMENDING CHAPTER 17, SECTIONS 17-201, AND 17-202 OF THE CODE OF ORDINANCES OF THE CITY OF WEST CHICAGO

BE IT ORDAINED by the City Council of the City of West Chicago, Illinois, in regular session assembled, that the City Code is amended as follows:

SECTION 1. That Chapter 17, Sections 17-201, and 17-202 of the Code of Ordinances of the City of West Chicago are hereby deleted in their entirety and the following language shall be substituted:

Sec. 17-201. Designated; compliance required.

It shall be unlawful for any person to operate a truck in excess of five (5) tons of weight, unless making a delivery thereon, upon any City street*:

**Exceptions noted in Sec. 17-202*

Sec. 17-202. Class II truck routes designated.

It shall be unlawful for any person to operate a truck exceeding the size and weight limitations for a Class II Highway as defined in the Illinois Compiled Statutes 625 ILCS 5/15 on the following streets:

Arthur Drive

Atlantic Drive

North Aurora Street – from the north right-of-way line of Washington Street to 120 feet north

Blackhawk Drive

Carolina Drive

Charles Court

Commerce Drive

Conde Street - from the west right-of-way of Neltnor Boulevard (IL Route 59) to 1,100 feet west

Discovery Drive.

Downs Drive
Enterprise Circle

Fenton Lane

Fremont Street - between Washington Street and Grand Lake Boulevard

Grand Lake Boulevard - between Fremont Street and the west end of Grand Lake Boulevard

Harvester Road

Hawthorne Lane - between Powis Road and Atlantic Drive

Helena Drive

Howard Drive

Industrial Drive

Innovation Drive

Kress Creek Drive

Main Street - between Neltor Boulevard (IL Route 59) and Washington Street

Northwest Avenue

Nuclear Drive

Powis Court

Shingle Oak Drive – from the east right-of-line of Atlantic Drive to 650 feet east

Technology Boulevard

Topsoil Drive

Town Road - between Washington Street and the Burlington Northern Railroad

Washington Street - between Roosevelt Road (IL Route 38) and North Aurora Street

Wegner Drive

Western Drive

Winston Street

SECTION 2. All Ordinances and Resolutions or parts thereof, in conflict with the provisions of this Ordinance are to the extent of such conflicts, expressly repealed.

SECTION 3. This Ordinance shall be in full force and effect from and after its publication, as provided by law.

SECTION 4. That this Ordinance shall be in full force and effect ten (10) days from and after its passage, approval, and publication in pamphlet form as provided by law.


