**AN ORDINANCE OF THE CITY OF WEST CHICAGO AMENDING CHAPTER 17,
ARTICLE XVII, DIVISION 16, OF THE CODE OF ORDINANCES REGARDING
TURN RESTRICTIONS – PURNELL ROAD AND GARY’S MILL ROAD**

WHEREAS, the DuPage County Board adopted certain traffic control restrictions for the intersection of Purnell Road and Gary’s Mill Road when it approved the Trillium Farms Subdivision; and

WHEREAS, the City of West Chicago (hereinafter the “City”) subsequently approved an annexation of land owned by the DuPage County Forest Preserve District that resulted in this intersection now becoming the jurisdiction of the City; and

WHEREAS, the City must now add these restrictions to the Code of Ordinances to allow for their enforcement by City officials.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of West Chicago, in regular session assembled as follows:

Section 1. That Chapter 17, Article XVII, Division 16 of the Code of Ordinance of the City of West Chicago is hereby re-named from “Right-Turns Only” to “Turn Restrictions” and that Section 17-246 is deleted in its entirety and the following language shall be substituted:

“Sec. 17-246. - Designated.

(a) Right turns only will be permitted as follows:

Traffic on the west approach entering Route 59 (Neltnor Boulevard) from Brown Street, Lester Street, Glen Avenue, and Dale Avenue approaches shall be permitted to make right turns only onto Route 59 (Neltnor Boulevard).

(b) Left turns are prohibited from Purnell Road onto Gary’s Mill road from 4:00 – 6:00 p.m. on weekdays.

(c) Rights turns are prohibited from Gary’s Mill Road onto Purnell Road from 7:00 a.m. – 9:00 a.m. on weekdays.”


Section 2. That all ordinances and resolutions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, expressly repealed.

Section 3. That this Ordinance shall be in full force and effect from and after its passage and publication in pamphlet form as provided by law.
