**ORDINANCE NO. 24-O-0014**

**AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF  
THE CITY OF WEST CHICAGO, CHAPTER 3, SECTION 3-10  
TO PROVIDE FOR A CLASS I LIQUOR LICENSE FOR LIVE MUSICAL  
PERFORMANCES ON CERTAIN LICENSED PREMISES**

WHEREAS, the City of West Chicago is a home-rule unit under Article VII, Section 6, of the Illinois Constitution of 1970; and,

WHEREAS, subject to said section, a home-rule unit of government may exercise any power and perform any function pertaining to its government and affairs for the protection of the public health, safety, morals, and welfare, including the retail sales and distribution of alcoholic beverages; and,

WHEREAS, further the Illinois Liquor Control Act of 1934, 235 ILCS 5/4-1 *et seq.* authorizes municipalities to license, control, and restrict the sales of alcoholic beverages within their boundaries; and,

WHEREAS, pursuant to its home-rule powers and the Act, the City has enacted an ordinance regulating the sales, delivery, serving, and consumption of alcoholic beverages at Secs. 3-1 *et seq.* of the Code of Ordinances of the City of West Chicago.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WEST CHICAGO, ILLINOIS, IN REGULAR SESSION ASSEMBLED AS FOLLOWS:

SECTION 1. That Section 3-10 of the Code is hereby amended to add the following (Liquor License Class B-4):

Class I license shall authorize any holder of a Class A-1, A-2, A-3, B-4, E-1, or E-3, to offer live musical performances on the licensed premises. Live musical performances on any premises licensed Class A-1, A-2, A-3, E-1, or E-3, are prohibited unless a Class I license shall have been issued in addition therefore. The Local Liquor Control Commissioner of the City may require the applicant for a Class I license to provide information about the facilities on the premises for accommodating live musical performances and may require that the licensee provide reasonable security measures at such performances. A Class I license shall expire, terminate, or be revoked or suspended simultaneously, without the taking of any action, with the expiration, termination, suspension, or revocation of the associated Class A-1, A-2, A-3, B-4, E-1, or E-3 license.

SECTION 2. That if any section or provision of this Ordinance is construed to be invalid or void, the remaining sections or provisions shall remain in full force and effect thereafter.



SECTION 3. That this Ordinance shall be in full force and effect ten (10) days from and after its passage, approval, and publication in pamphlet form as provided by law.
