ORDINANCE NO. 1618 - 2013

AN ORDINANCE OF THE CITY OF ROCKLEDGE, BREVARD COUNTY, FLORIDA, AMENDING SECTION 21-7 (a) (1) OF THEROCKLEDGE CODE ORDINANCES TO ADD MARTIN DRIVE, GROVES DRIVE AND MARLIN PLACE TO THE LIST OF STREETS LYING WEST OF FISKE BOULEVARD UPON WHICH GOLF CARTS MAY BE OPERATED; AMENDING SECTION 21-7(a) OF THE ROCKLEDGE CODE OF ORDINANCES TO ADD A NEW SUBSECTION (5) DESIGNATING SIDEWALKS AND CROSSWALKS WHICH CAN BE UTILIZED BY GOLF CARTS; DECLARING THAT INVALIDITY OF ANY PORTION HEREOF SHALL NOT AFFECT THE REMAINING PORTIONS OF THIS ORDINANCE; PROVIDING FOR THE EFFECTIVE DATE HEREOF AND FOR OTHER PURPOSES.

WHEREAS, the Rockledge City Council has received a request to authorize golf carts as a means of transportation from Marlin Manor subdivision to Robert A. Anderson Stormwater Park; and

WHEREAS, upon staff recommendation for approval of such a request, the Rockledge City Council has authorized the addition of certain streets, sidewalks and crosswalks for inclusion in Section 21-7 of the Rockledge Code of Ordinances allowing golf carts on such streets, sidewalk and crosswalks.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY
OF ROCKLEDGE, FLORIDA, AS FOLLOWS:

SECTION 1. Section 21-7(a)(1) of the Rockledge Code of Ordinances is amended by adding the following in their appropriate alphabetical position in the list of streets named therein:

Groves Drive Marlin Place Martin Drive **SECTION 2.** Section 21-7(a) of the Rockledge Code of Ordinances is amended to add subsection (5) to Section 21-7(a) as follows:

- (5) The following sidewalks and crosswalks which lie west of Fiske Boulevard:
 - (a) Sidewalk on the south side of Pluckebaum Road from the intersection of Marlin Place west to the crosswalk crossing Pluckebaum Road at Robert A.

 Anderson Stormwater Park.
 - (b) Crosswalk crossing Pluckebaum Road at Robert A.

 Anderson Stormwater Park from the south right-of-way line to the north right-of-way line.

SECTION 3. The provisions of this Ordinance are severable, and if any section, sentence, clause, or phrase hereof is for any reason held to be unconstitutional, invalid, or ineffective, such holding shall not affect the validity of the remaining portions of this Ordinance, it being expressly declared to be the City Council's intent that it would have passed the valid portions of this Ordinance without the inclusion therein of any invalid portion or portions.

SECTION 4. This Ordinance shall become effective ten (10) days following its adoption and signed by the Chairman of the City Council.
