

The following ordinance having been introduced at a duly convened meeting on December 13, 2016, and notice of its introduction having been published in the official journal and a public hearing having been held in connection therewith on this date, was offered for final adoption by Francis Touchet, Jr and seconded by Francis Plaisance:

**ORDINANCE**

**16-12**  
**WHEREAS**, the Mayor has proposed an amendment to the 2016 fiscal year budget for the City and further proposed a budget for the 2017 fiscal year;

**BE IT ORDAINED** by the City Council of the City of Abbeville (the "Governing Authority"), acting as the governing authority of the City of Abbeville, State of Louisiana, that:

**An ordinance adopting the Annual Budget of Revenues and Expenditures for the Fiscal Year January 1 through December 31, 2017 and amending the Annual Budget of Revenues and Expenditures for the Fiscal Year January 1 Through December 31, 2016, for the City of Abbeville, Louisiana.**

**Section I:** The attached detailed estimate of revenues as reflected in the consolidated statement, and such other fiscal exhibits and information as required by Louisiana Local Government Budget Act, be and the same is hereby adopted to serve as the Budget of Revenues for the Fiscal Year January 1 to December 31, 2017;

**Section II:** The attached detailed statement of anticipated expenditures as reflected in the consolidated statement and such other fiscal exhibits and information as required by the Louisiana Local Government Budget Act, be and the same is hereby adopted to serve as the budget of Expenditures for Fiscal Year January 1 to December 31, 2016;

**Section III:** The adoption of the Budget of Expenditures as reflected in the attached line-item budget containing object of expenditure classifications shall be declared to be the appropriation of the amounts set therein as established in each budget classification of object of expenditure;

**Section IV:** The amounts appropriated for all accounts shall not exceed the amounts fixed therefore in the Budget of Expenditures. Nothing contained in this section shall be construed to prohibit the governing authority from amending to making an appropriation to and for a contingent fund to be used in cases of emergency;

**Section V:** The Fiscal Year Budget for January 1 to December 31, 2016 is hereby amended as reflected in the detailed statements of revenues and expenditures which are incorporated in the 2016 budget, as submitted.

This ordinance having been read section by section and having been considered in the same manner, the vote thereon is as follows:
