AN ORDINANCE OF THE CITY OF ALICE, TEXAS, PROVIDING THAT THE CODE OF ORDINANCES, PART II, CHAPTER 58 ARTICLE IV, USE OF CITY PROPERTY, PUBLIC GATHERINGS, PARADES; USE OF PARKS, DIVISION 2, PERMIT - BE AMENDED BY THE ADDITION OF A NEW SECTION 58-115, ENTITLED "INSURANCE REQUIREMENTS"; ESTABLISHING A FINE NOT TO EXCEED \$200.00 FOR VIOLATIONS; DIRECTING THE CITY CLERK TO PUBLISH NOTICE OF THE PASSAGE OF THIS ORDINANCE; AND PROVIDING FOR AN EFFECTIVE DATE, A PENALTY CLAUSE, A REPEALER CLAUSE AND A SEPARABILITY CLAUSE.

# IT IS THEREFORE ORDAINED BY THE CITY COUNCIL OF THE CITY OF ALICE, ZEXAS THAT:

WHEREAS, the City of Alice recognizes that Special Events organized by individuals, private organizations, and non-profits serve an important role in enhancing the city's quality of life and can provide benefits to the community as a whole. In an effort to treat all persons and groups uniformly, to facilitate the successful staging of these special events, and to be mindful of the efficient use of available facilities and resources, the City will commit staff time and facilities to review applications to hold special events and assist the organizers to ensure that special events have an overall positive effect upon the community, its resources and to adequately protect the public safety, health and welfare of the community.

**SECTION 1**. The Code of Ordinances of the City of Alice shall be amended by adding a new Section 58-115, entitled "Insurance Requirements", to read as follows:

**Sec. 58-115** The City of Alice shall condition the issuance of a special events permit by imposing reasonable insurance requirements as follows:

1. Liability Insurance Required: The applicant or sponsor of a Special Event must possess or obtain liability insurance to protect against loss from liability imposed by law for damages on account of bodily injury or property damage arising from the Special Event. A certificate of insurance must be filed with the City prior to issuance of the Special Event permit. The certificate of insurance must name the City, its officials, employees and agents as additional insureds. Insurance coverage must be maintained for the duration of the Special Event.

2. Minimum Limits: Insurance coverage must be a commercial general liability policy, the minimum limits must be at least \$1,000,000 coverage per occurrence and \$2,000,000 aggregate coverage for general liability. The policy must also include an endorsement for liquor liability when applicable. The

City Council may require additional endorsements depending upon the type of Special Event and proposed activities.

3. Waiver or Reduction of Required Limits: The City may waive or reduce the insurance requirements of this Chapter under the following circumstances:

a) The applicant or officer of the sponsoring organization signs a verified statement that it believes that the Special Event's purpose is First Amendment expression and that the cost of obtaining the insurance is so financially burdensome that it would constitute an unreasonable burden on the right of First Amendment expression;

b) The applicant or an officer of the sponsoring organization signs a verified statement that the insurance coverage required by this Chapter is impossible to obtain; or

c) The City Council determines that the insurance requirements are in excess of the reasonable risk presented by the proposed Special Event.

**SECTION 2**. That all ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to the extent of such conflict.

**SECTION 3**. The Alice City Code, as amended, shall remain in full force and effect, save and except as amended by this Ordinance.

**SECTION 4**. If any section, paragraph, sentence, or clause, phrase or word of this Ordinance is declared unconstitutional or invalid for any purpose, the remainder of this Ordinance shall not be affected thereby and to this end the provisions of this Ordinance are declared to be severable.

**SECTION 5.** It is hereby found and determined that the meeting at which this Ordinance was passed was open to the public, as required by section 551.001, et seq., of the Local Government Code, and that advance public notice of the time, place and purpose of said meetings was given.

**SECTION 6**. It is the intention of the City Council that this Ordinance shall become a part of the Alice City Code and it may be renumbered and codified therein accordingly.

**SECTION 7.** That the Office of the City Clerk shall publish this Ordinance in a newspaper of general circulation in the City of Alice in compliance with the provisions of the Charter and/or Code of Ordinances, which publication shall be sufficient if it contains the title of this Ordinance, the penalty provided therein for violation thereof, and the effective date of the Ordinance.

**SECTION 8.** That this Ordinance shall take effect on the 11<sup>th</sup> day after its passage and publication as required by law.


