**AN ORDINANCE BY COMMUNITY DEVELOPMENT/HUMAN SERVICES COMMITTEE TO AMEND CITY OF ATLANTA CODE OF ORDINANCES PART II, ARTICLE I, DEPARTMENT OF PARKS AND RECREATION, CHAPTER 110 TO PROVIDE FOR THE RESERVATION OF PLAYGROUNDS WITHIN CITY PARKS; AND FOR OTHER PURPOSES.**

WHEREAS, City of Atlanta Code of Ordinances (“City Code”) Part II Article I Chapter 110 (“Chapter 110”) outlines the framework pursuant to which areas, spaces, and facilities within City of Atlanta (“City”) parks are regulated and utilized; and

WHEREAS, the Commissioner of Parks and Recreation recommends that Chapter 110 be amended to provide for the reservation of playgrounds within City parks; and

WHEREAS, it is in the best interest of the City to amend Chapter 110 of the City Code to allow for the reservation of playgrounds within City parks.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS as follows:

SECTION 1: Part II, Article I, Department of Parks and Recreation, Chapter 110 is hereby amended with new language in bold, underlined font and deleted language in bold, strikethrough font.

Sec.110-7. - Playgrounds. All persons desiring to reserve use of city playgrounds shall comply with administrative and scheduling guidelines of the Department of Parks and Recreation which are on file in the office of the commissioner of the Department of Parks and Recreation.

Secs. 110-~~87~~-110-30. - Reserved.

SECTION 2: All ordinances or parts of ordinances in conflict herewith are hereby waived to the extent of the conflict only.
