**AN ORDINANCE BY COUNCILMEMBER NATALYN ARCHIBONG AS
SUBSTITUTED BY COMMITTEE ON COUNCIL**

**AN ORDINANCE AMENDING PART II, CHAPTER 2, ARTICLE XVI, DIVISION 1,
SECTION 2-1852 OF THE ATLANTA CODE OF ORDINANCES, TITLED
"PROCEDURE FOR THE APPOINTMENT BY THE FULL COUNCIL OF
INDIVIDUALS OR COUNCILMEMBERS TO BOARDS, COMMISSIONS AND
AUTHORITIES"; REQUIRING THE AFFECTED CITY BOARD, COMMISSION, OR
AUTHORITY TO PROVIDE 30 BUSINESS DAYS NOTICE OF ANY VACANCY TO
THE MUNICIPAL CLERK AND REQUIRING THE CLERK TO PROVIDE NOTICE
OF SUCH TO THE CHAIR OF THE COMMITTEE OF PURVIEW WITHIN 14
BUSINESS DAYS; AND FOR OTHER PURPOSES;**

WHEREAS, The Atlanta City Council desires to have a timelier, more efficient process for filling vacancies on Boards and Commissions; and

WHEREAS, The Atlanta City Council needs to have reports from the liaisons in order to make better informed decisions regarding public policy for the City of Atlanta.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF
ATLANTA, GEORGIA AS FOLLOWS:**

SECTION 1: Chapter 2, Section 2-1852 of the Boards, Councils, Commissions, and Authorities, currently reads as follows:

1(a)"Whenever a position on a board, commission or authority shall be or becomes vacant, notice of such vacancy shall be submitted in writing to the municipal clerk who shall notify the chair of the committee on council, with a copy of said notice being submitted to the president of the city council."

Is hereby amended to hereafter read as follows:

1(a)"Whenever a position on a board, commission or authority shall be or becomes vacant, notice of such vacancy shall be submitted in writing to the Municipal Clerk from the city board within 30 business days, who shall then notify the Chair of the Committee on Council, with a copy of said notice being submitted to the president of the city council, within 14 business days of receiving the notice of vacancy.

SECTION 2: That all ordinances or parts of ordinances in conflict with this ordinance shall be waived to the extent of the conflict only.
