AN ORDINANCE AMENDING CITY OF ATLANTA CODE OF ORDINANCES CHAPTER 38, ARTICLE II, MUNICIPAL CEMETERIES, DIVISION 2 OAKLAND CEMETERY, SECTION 38-45 (a) ENTITLED "SCHEDULE OF CHARGES FOR GUIDED TOURS" INCREASING CERTAIN FEES FOR TOURS AT OAKLAND CEMETERY ON BEHALF OF THE DEPARTMENT OF PARKS AND RECREATION; ALL REVENUE DERIVED FROM THE INCREASED AND CREATED FEES TO BE DEPOSITED INTO TRUST FUND ACCOUNT 7701(PERPETUAL CARE) 140209(PRC OAKLAND CEMETERY) 3491001(FEES; BURIAL) 4950000(CEMETERY) 600365(OAKLAND CEMETERY) 69999(NON-CAPITAL TRUST) AND EXPENDED FROM THE TRUST FUND ACCOUNT 7701(PERPETUAL CARE) 140209(PRC OAKLAND CEMETERY) 5212001(PRO. SERVICES) 4950000(CEMETERY) 600365(OAKLAND CEMETERY) 69999(NON-CAPITAL TRUST); AND FOR OTHER PURPOSES.

WHEREAS, the Historic Oakland Cemetery is a City of Atlanta owned cemetery located between the CSX rail yard on the north side, Boulevard on the east side, Memorial Drive on the south side, and Oakland Avenue on the west side, and whose address is 248 Oakland Avenue SE (the "Cemetery"); and

WHEREAS, the Cemetery offers guided tours and charges fees in accordance with the City of Atlanta Code of Ordinances; and

WHEREAS, the Department of Parks and Recreation desires to increase certain fees for guided tours to support increasing costs of continued restoration and maintenance of the Cemetery; and

WHEREAS, the proposed increases are equivalent to fees charged of comparable public attractions in the Atlanta area.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1: That Chapter 38, Article II, Municipal Cemeteries, Division 2 Oakland Cemetery, Section 38-45 (a), Schedule of Charges for Guided Tours which currently reads:


Sec. 38-45. - Schedule of charges for guided tours.

(a) The following fee schedule of charges is adopted by the department for guided tours of the grounds in historic Oakland Cemetery:

- (1) Students (ages 7—22)\$5.00
- (2) Senior citizens (ages 65 and above)3.00
- (3) Adults (ages 23—64)10.00
- (4) Adults (ages 55—64)3.00

Group rates: Students (Age 7—22, with ID)\$5.00
Adults (Age 23—64)10.00
Senior Citizen (Age 65 and above)4.00

- (6) Minimum charge for any adult group of less than ten30.00
- (7) Family of four, two adults, two children26.00
Each additional child5.00

Is hereby amended to read as follows:

Sec. 38-45. - Schedule of charges for guided tours.

(a) The following fee schedule of charges is adopted by the department for guided tours of the grounds in historic Oakland Cemetery:

- (1) Students (ages 7—22)\$6.00
- (2) Senior citizens (ages 65 and above)5.00
- (3) Adults (ages 23—64)10.00
- (4) Group rates: Students (Age 7—22, with ID)\$6.00
Adults (Age 23—64)12.00
Senior Citizen (Age 65 and above)6.00
- (5) Minimum charge for any adult group of less than ten50.00
- (6) Family of four, two adults, two children28.00
Each additional child6.00

SECTION 2: That all revenues derived from these increased and created fees at the Oakland Cemetery will be deposited into the Trust Fund Account Number 7701(PERPETURAL CARE) 140209(PRC OAKLAND CEMETERY) 3491001(FEES; BURIAL) 4950000(CEMETERY) 600365(OAKLAND CEMETERY) 69999(NON-CAPITAL TRUST) AND EXPENDED FROM THE TRUST FUND ACCOUNT 7701(PERPETURAL CARE) 140209(PRC OAKLAND CEMETERY) 5212001(PRO. SERVICES) 4950000(CEMETERY) 600365(OAKLAND CEMETERY) 69999(NON-CAPITAL TRUST).

SECTION 3: All ordinances and resolutions in conflict herewith are hereby waived for purposes of this Ordinance only, and only to the extent of said conflict.
