

THE CITY OF ST. CLAIR SHORES ORDAINS THAT CHAPTER 21.451 (SECTION 15B-21) ENTITLED "THROUGH STREETS; SCHEDULE; STOP SIGNS REQUIRED" SHALL BE AMENDED BY THE ADDITION OF THE FOLLOWING:

Section 21.451 - Through streets; schedule; stop signs required by adding the following:

- (195) Ursuline at Blackburn (East Intersection), a STOP sign shall be placed at the southeast corner to stop northbound Ursuline traffic before entering Blackburn. (ord. eff. Nov.23,2020)
- (196) Wood at Valera, a STOP sign shall be placed at the northeast corner to stop westbound Valera traffic before entering Wood. (ord. eff. Nov.23,2020)
- (197) Share at Fairway, a STOP sign shall be placed at the northwest corner to stop southbound Fairway traffic before entering Share. (ord. eff. Nov.23,2020)
- (198) Timberidge at Courtland, a STOP sign shall be placed at the northeast corner to stop westbound Timberidge before entering Courtland. (ord. eff. Nov.23,2020)
- (199) Pleasant at Grove, a STOP sign shall be placed at the southwest corner to stop eastbound Pleasant traffic before entering Grove. (ord. eff. Nov.23,2020)
- (200) Westbury at Gladhill Lane, a STOP sign shall be placed at the northwest corner to stop southbound Gladhill Lane traffic before entering Westbury. (ord. eff. Nov.23,2020)
- (201) Westbury at Park Lane, a STOP sign shall be placed at the northwest corner to stop southbound Park Lane traffic before entering Westbury. (ord. eff. Nov.23,2020)
- (202) Gary Lane at Norcrest, a STOP sign shall be placed at the southwest corner to stop eastbound Norcrest traffic before entering Gary Lane. (ord. eff. Nov.23,2020)
- (203) Gary Lane at Westbury, a STOP sign shall be placed at the northwest corner to stop southbound Gary Lane traffic before entering Westbury. (ord. eff. Nov.23,2020)
- (204) Gary Lane at Greencrest, a STOP sign shall be placed at the southwest corner to stop eastbound Greencrest traffic before entering Gary Lane (ord. eff. Nov.23,2020)
- (205) Norcrest at Middlesex, a STOP sign shall be placed at the northeast corner to stop westbound Middlesex traffic before entering Norcrest. (ord. eff. Nov.23,2020)
- (206) Norcrest at Greencrest, a STOP sign shall be placed at the northeast corner to stop westbound Greencrest traffic before entering Norcrest. (ord. eff. Nov.23,2020)
- (207) Norcrest at Park Lane, a STOP sign shall be placed at the southeast corner to stop northbound Park Lane traffic before entering Norcrest. (ord. eff. Nov.23,2020)
- (208) Van Dover at Rhode Island, a STOP sign shall be placed at the southwest corner to stop eastbound Van Dover traffic before entering Rhode Island. (ord. eff. Nov.23, 2020)

Any ordinance or parts of any ordinance in conflict with any provisions of this ordinance are hereby repealed. This ordinance shall become effective upon publication by the City Clerk.
