AN ORDINANCE AMENDING SECTION 26-263 OF THE
CITY CODE, RELATING TO PENALTIES FOR PARKING

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CAPE GIRARDEAU,
MISSOURI, AS FOLLOWS

ARTICLE 1 All of Section 26-263 of the Code of Ordinances
of the City of Cape Girardeau, Missouri, reading as follows

Sec 26-263 - Penalties

- (a) Any person accused of violating section 26-246, 26-247, 26-248, 26-249, 26-250, 26-251, 26-252, 26-253, 26-255, 26-256, 26-257, 26-258, 26-259, 26-261, or 26-262, upon conviction or upon entering a plea of guilty, shall pay a fine according to the following schedule
 - (1) Twenty-five dollars (\$25 00) if paid within seven (7) days following the violation
 - (2) Thirty-five dollars (\$35 00) if paid more than seven (7) days but within thirty (30) days following the violation
 - (3) Forty-five dollars (\$45 00) if paid more than thirty (30) days following the violation
- (b) Any person accused of violating section 26-260 upon conviction or upon entering a plea of guilty, shall pay a fine according to the following schedule
 - (1) Fifty dollars (\$50 00) if paid within seven (7) days following the violation
 - (2) Not more than two hundred dollars (\$200 00) if paid more than seven (7) days following the violation

is hereby repealed in its entirety, and a new Section 26-263 is hereby enacted in lieu thereof, in words and figures, to read as follows

Sec 26-263 Penalties

- (a) Any person accused of violating section 26-246, 26-247, 26-248, 26-249, 26-250, 26-251, 26-252, 26-253, 26-255, 26-256, 26-257, 26-258, 26-259 or

26-261, upon conviction or upon entering a plea of guilty, shall pay a fine according to the following schedule

- (1) Thirty-five dollars (\$35 00) if paid within thirty (30) days following the violation
- (2) Forty-five dollars (\$45 00) if paid more than thirty days (30) days following the violation


(b) Any person accused of violating section 26-260 upon conviction or upon entering a plea of guilty, shall pay a fine according to the following schedule

- (1) Fifty dollars (\$50 00) if paid within seven (7) days following the violation
- (2) Not more than three hundred dollars (\$300 00) if paid more than seven (7) days following the violation


ARTICLE 2 It is the intention of the governing body and it is hereby ordained that the provisions of this ordinance shall become and be made a part of the Code of Ordinances of the City of Cape Girardeau, Missouri, and the sections of this Code may be renumbered to accomplish such intention

ARTICLE 3 This ordinance shall be in full force and effect on July 1, 2015
