At a regular meeting of the City Council for the City of Ecorse, held on the 27<sup>th</sup> day of August, 2019 in the Council Chambers of City Hall location at 3869 Jefferson Avenue in the City of Ecorse, Wayne Co., Michigan, the following resolution was offered by: Councilman Brown; Seconded by: Councilman Sherard to approve the enactment of the following ordinance to add a NEW Chapter 28 which shall be designated as “Miscellaneous Business Regulations” and adding a new Article 1, PROHIBITION OF MARIJUANA BUSINESSES AND ESTABLISHMENTS, in the City of Ecorse, Wayne County, Michigan as authorized by Ballot Proposal No. 1 of 2018, as follows:

AN ORDINANCE TO AMEND THE ECORSE CITY CODE  
BY ADDING A NEW CHAPTER 28, “PROHIBITION OF  
MARIJUANA BUSINESSES” AND A NEW ARTICLE I  
“PROHIBITION OF MARIJUANA BUSINESSES AND  
ESTABLISHMENTS “AND SHALL INCLUDE NEW  
SECTIONS 28-1 THROUGH 28-3 OF SAID CODE.

THE CITY OF ECORSE ENACTS AND ORDAINS:

**CHAPTER 28, “PROHIBITION OF MARIJUANA BUSINESSES”**

ARTICLE I: INTENT – MARAJUANA ORIENTED BUSINESSES

It is hereby declared by the City of Ecorse that the intent of this ordinance, pursuant to the authority granted the City pursuant to the Michigan Regulation and Taxation of Marijuana Act, to prohibit the establishment, operation, or functioning of any marijuana oriented business in the City of Ecorse to the maximum extent permitted by law.

SECTION 1: PROHIBITION OF MARIJUANA BUSINESSES AND ESTABLISHMENTS

Pursuant to the Michigan Regulation and Taxation of Marijuana Act the City of Ecorse hereby elects to exercise its authority and does hereby prohibits the establishment of any form of business entity from establishing, constructing or operating any form of marijuana related business, and such business entities are strictly prohibited in the corporate boundaries of the City of Ecorse.

SECTION II: IMMEDIATE EFFECT

It is hereby determined that to protect the health, safety and welfare of the community and its citizens, and to protect the public health and maintain peace in the community. Therefore, it is the determination of the City Council that this ordinance be given immediate effect upon publication. The City Clerk is hereby directed to take all actions necessary to comply with this section of the Ordinance including the posting, publication, and all mandates of the City Charter to insure this ordinance shall become immediately effective.

SECTION 3: REPEAL OF CONFLICTING ORDINANCES

Any ordinance or part or parts of any existing ordinance of the City of Ecorse ordinance which conflicts with the provisions of this ordinance shall hereby be deemed repealed.

We hereby certify the forgoing to be a true copy of the ordinance as enacted by the City Council for the City of Ecorse on the 27<sup>th</sup> day of August, 2019, and that all requisite requirements of the City Charter have been observed.
