

**ORDINANCE NO. 2023-4910**

**AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF EDINBURG, TEXAS AT TITLE III, ADMINISTRATION, CHAPTER 30, ADMINISTRATIVE CODE, TO PROVIDE FOR CHANGES SECTION 30.055 (F), IN ACCORDANCE WITH SECTION 30.030(C) AND SECTION 30.031(A) AND (G); PROVIDING FOR WAIVER OF THE THREE SEPARATE READINGS; PROVIDING A REPEALER CLAUSE; PROVIDING A SAVINGS CLAUSE; PROVIDING FOR ITS CODIFICATION IN THE CODE OF ORDINANCES OF THE CITY; PROVIDING FOR PUBLICATION AND EFFECTIVE NOVEMBER 2, 2023; AND, ORDAINING OTHER MATTERS PERTAINING TO THIS SUBJECT MATTER THEREOF.**

**WHEREAS**, in order to continue providing a comprehensive and systematic plan of administrative organization for the City, as promulgated by the City Charter, the City Council deems it appropriate and necessary to amend CHAPTER 30 ADMINISTRATIVE CODE, of the City of Edinburg, Texas.

**NOW, THEREFORE, BE IT ORDAINED BY CITY COUNCIL OF THE CITY OF EDINBURG, THAT:**

**SECTION I. THE CODE OF ORDINANCES OF THE CITY OF EDINBURG, TEXAS AT TITLE III, ADMINISTRATION, CHAPTER 30, ADMINISTRATIVE CODE, C E R T I F I C A T I O N P A Y §30.055 CERTIFICATION PAY, IS HEREBY AMENDED AND SHALL READ AS FOLLOWS:**

**§30.055 (F)** In addition to wage or salary pay, cumulative certification pay is available to Building Safety Department employees that accomplish licenses and certifications based on certain testing requirements and qualifications as follows:

<b>Certification Pay Plan - Building Safety</b>

Any ICC Plans Examiner up to five (5)	\$500 each
Any ICC Commercial Inspector up to four (4)	\$500 each
Any ICC Residential Inspector up to four (4)	\$500 each
Any ICC Code Specialist up to four (4)	\$500 each
Journeyman or Master State of Texas License	\$500 each
ICC Master Code Professional	\$1,000

ICC Permit Technician	\$500
ICC Accessibility Plans Examiner and Inspector	\$500
Texas State Plumbing License	\$500
Texas Plumbing Medical Gas License	\$500
Customer Service Inspector (Cross-Contamination)	\$500
OSSF – Designated Representative & Site Evaluator (Septic Tank Inspections)	\$500
Basic Code Enforcement License	\$500
ICC Zoning Inspector	\$500
ICC Property Maintenance & Housing Inspector	\$500

**SECTION II. WAIVER CLAUSE**

The requirement of three separate readings of this Ordinance is hereby dispensed with by a vote of not less than a majority of all the members of the City Council.

**SECTION III. REPEALER CLAUSE**

This Ordinance shall be cumulative of all other ordinances dealing with the same subject and any provision of any Ordinance in direct conflict with any provision of this Ordinance is hereby repealed and the provisions of this Ordinance shall supersede any provisions in conflict herewith; all provisions of any other Ordinance not in conflict herewith shall remain in full force and effect.

**SECTION IV. SAVINGS CLAUSE**

If any section, part, or provision of this Ordinance is declared unconstitutional or invalid, by a court of competent jurisdiction, then, in that event, it is expressly provided, and it is the intention of the City Council in passing this Ordinance that its parts shall be severable and all other parts of this Ordinance shall not be affected thereby and they shall remain in full force and effect.

**SECTION V. CODIFICATION CLAUSE**


The provisions of Section I this Ordinance are to be published in the location indicated in the Code of Ordinances of the City of Edinburg, Texas, as soon as possible.

**SECTION VI. PUBLICATION AND EFFECTIVE DATE**


This Ordinance shall take effect immediately upon its passage and publication according to law.


