

ORDINANCE NO. 2018-4279

AN ORDINANCE OF THE CITY OF EDINBURG, TEXAS, AMENDING THE CODE OF ORDINANCES AT TITLE ix- GENERAL REGULATIONS, CHAPTER 97 PARKS AND RECREATION, 97.84 YOUTH CONNECTION PROGRAM FEES AND DAY PASSES, IS AMENDED BY RENAMING SECTION TO RECREATION CENTER MEMBERSHIP, FEES AND DAY PASSES AND AMENDING THE FEE STRUCTURE. PROVIDING FOR WAIVER OF THREE SEPARATE READINGS; PROVIDING A REPEALER CLAUSE; CONTAINING A SAVINGS CLAUSE; PROVIDING FOR PUBLICATION AND EFFECTIVE DATE; PROVIDING FOR CODIFICATION; AND ORDAINING OTHER PROVISIONS RELATED TO THE SUBJECT MATTER HEREOF.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EDINBURG, TEXAS, AS FOLLOWS:

SECTION I. AUTHORITY OF LAW. The City Council specifically finds that all requirements of law have been met in the passing of this Ordinance.

SECTION II. The Code of Ordinances City of Edinburg, is hereby amended Title IX – General Regulations, Chapter 97 Parks and Recreation, 97.84 Youth Membership Program and fees and Day Passes as follows: Amending 97.84 section to Recreation Center Membership, fees and day passes.

SECTION III. WAIVER. The requirement of three (3) separate readings of this Ordinance is hereby dispensed with by a vote not less than a majority of all the members of the City Council.

SECTION IV. REPEALER CLAUSE. This Ordinance shall be cumulative of all other ordinances dealing with the same subject any provision of any ordinance I direct conflict with any provision of the ordinance is hereby repealed, and the provisions of this Ordinance shall supersede any provisions in conflict herewith; all provisions of any other ordinance not in conflict herewith shall remain in full force and effect.

SECTION V. SEVERABILITY CLASUE. IF ANY SECTION, PART, OR PROVISION OF THIS Ordinance is declared unconstitutional or invalid, by a court of competent jurisdiction, then, in that event, it is expressly provided, and it is the intention of the City Council in passing the Ordinance that its parts shall be severable, and all other parts of this Ordinance shall not be affected thereby and they shall remain in full force and effect.

SECTION VI. PUBLICATION AND EFFECTIVE DATE. This Ordinance shall take effect immediately upon its passage and publication according to law.

SECTION VII. CODIFICATION. The provisions of Section II through X of this Ordinance shall be published in the Code of Ordinances of the City of Edinburg, Texas, as soon as practicable.
