

**ORDINANCE**  
**2017-13**

AN ORDINANCE TO AMEND THE CODE OF ORDINANCES OF THE CITY OF EUFAULA ALABAMA, CHAPTER 10, RELATING TO ALCOHOL BEVERAGES, TO AUTHORIZE SUNDAY ALCOHOL SALES ON NEW YEAR'S EVE AT LOUNGE RETAIL, LOUNGE PACKAGE STORES, OR CLUB LIQUOR CLASS I AND CLASS II LICENSEES IN THE CITY OF EUFAULA.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EUFAULA, ALABAMA AS FOLLOWS:

WHEREAS, local businesses that are permitted to sell alcoholic beverages on Sundays in Eufaula have requested the City Council allow Sunday Sales on Sundays on which New Year's Eve (December 31<sup>st</sup>) occurs so they can compete with surrounding communities that offer such beverages on Sunday and bring in more tourism to the City; and

WHEREAS, the City passed Ordinance 2017-7 authorizing restaurants and hotels properly licensed by the Alcoholic Beverage Control Board and the City of Eufaula located within the corporate limits of the City of Eufaula to sell alcoholic beverages for on-premises consumption between 12:00 p.m. (noon) to 9:30 p.m. on Sundays and on Sundays on which New Year's Eve (December 31) occurs, after 12:00 p.m. and the sale of beer and table wine by retailers properly licensed by the Alcoholic Beverage Control Board and the City of Eufaula with a retail table wine and/or retail beer license for on-premises and/or off-premises consumption between 12:00 p.m. (noon) to 9:30 p.m. on Sundays and on Sundays on which New Year's Eve (December 31) occurs, after 12:00 p.m.

WHEREAS, Act 2017-436 authorizes the governing body of the City of Eufaula in Barbour County, by ordinance, to regulate and permit the sale of alcoholic beverages after 12:00 p.m. on Sunday, as determined by the governing body, by properly licensed retail licensees of the Alcoholic Beverage Control Board and the City of Eufaula; and

WHEREAS, pursuant to such authorization and in compliance with applicable laws, the City Council deliberated on the request for Sunday alcohol sales and determined that an ordinance allowing Sunday alcohol sales in the City of Eufaula would be in the best interest of the citizens and the City as a whole.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EUFAULA, ALABAMA, THAT THE CODE OF ORDINANCES OF THE CITY OF EUFAULA ALABAMA, CHAPTER 10, RELATING TO ALCOHOL BEVERAGES, BE AMENDED TO AUTHORIZE SUNDAY ALCOHOL SALES AT LOUNGE RETAIL, LOUNGE PACKAGE STORES, OR CLUB LIQUOR CLASS I AND CLASS II LICENSEES ON NEW YEARS' EVE IN THE CITY OF EUFAULA:

"Section 10-13: Sunday Sales.

(a). Restaurants and hotels properly licensed by the Alcoholic Beverage Control Board and the City of Eufaula located within the corporate limits of the City of Eufaula are allowed to sell alcoholic beverages for on-premises consumption between 12:00 p.m. (noon) to 9:30 p.m. on Sundays and on Sundays on which New Year's Eve (December 31) occurs, after 12:00 p.m.

(b). The sale of beer and table wine by retailers properly licensed by the Alcoholic Beverage Control Board and the City of Eufaula with a retail table wine and/or retail beer license for on-premises and/or off-premises consumption is permitted between 12:00 p.m. (noon) to 9:30 p.m. on Sundays and on Sundays on which New Year's Eve (December 31) occurs, after 12:00 p.m.

(c). It shall be unlawful for licensees licensed by the Alcoholic Beverage Control Board and the City of Eufaula as lounge retail, lounge package stores, or club liquor class I and class II, within the corporate limits of the City of Eufaula to sell alcoholic beverages on Sunday except as already permitted by the Code of Alabama *and on Sundays on which New Year's Eve (December 31) occurs sales are permitted after 12:00 p.m. (noon)*. Nothing herein shall be interpreted as local legislation authorizing Sunday sales at lounge retail, lounge package stores, or club liquor class I and class II, under Alabama Code § 28-3A-25 (19) & (20)."

The City of Eufaula hereby reserves the right to enact, by ordinance, such policies it deems appropriate to regulate any aspect of Sunday alcoholic beverages sales.


Any portion of another ordinance of the City of Eufaula that conflicts with the provisions of this ordinance is hereby repealed.

If any provision of this ordinance shall be declared unconstitutional, or otherwise invalid, it shall have no effect on the remaining provisions of this ordinance.


This ordinance shall become effective upon its adoption and publication as required by law.


