AN ORDINANCE AMENDING SECTION 2-142(a) OF THE AIKEN CITY CODE TO ADD THE EQUINE COMMITTEE TO THE LISTING OF CITY BOARDS AND COMMISSIONS.

WHEREAS, Section 2-142(a) of the Aiken City Code provides a listing of the boards and commissions that are governed by Sec. 2-142 of the Aiken City Code; and

WHEREAS, the Equine Committee (originally referred to as the Horse Committee) was developed to deal with issues brought up either by City Council or within the Aiken community dealing strictly with horses and it was originally envisioned that they would not meet on a regular basis; and

WHEREAS, since the Equine Committee was only expected to meet once a year unless otherwise necessary, this committee was not included in the listing of boards and commissions that were governed by Section 2-142 of the Aiken City Code; and

WHEREAS, the Council of the City of Aiken has reviewed the Equine Committee and determined that this committee should be governed by Section 2-142 of the Aiken City Code and that Section 2-142(a) should be amended as set forth herein; and

WHEREAS, the Council of the City of Aiken has concluded that the adoption of the proposed amendment to the Aiken City Code is essential to the general health, safety, welfare and economic stability of the City and is in the best interest of its citizens;

NOW, THEREFORE, THE COUNCIL OF THE CITY OF AIKEN HEREBY ORDAINS THAT:

<u>Section 1:</u> The language in Section 2-142(a) of the Aiken City Code shall be amended to read as follows:
