AN ORDINANCE OF THE CITY OF FORT LAUDERDALE, FLORIDA, CREATING SCHEDULE X OF THE PAY PLAN OF THE CITY OF FORT LAUDERDALE, FLORIDA, BY CREATING SEVERAL CLASSES, ADOPTING SCHEDULE 10 NONBARGAINING UNIT COMMUNITY REDEVELOPMENT AGENCY (CRA) PAY RANGE AMOUNTS FOR SCHEDULE X OF THE PAY PLAN OF THE CITY OF FORT LAUDERDALE, FLORIDA, AMENDING SECTION 20-83 OF THE CODE OF ORDINANCES OF THE CITY OF FORT LAUDERDALE, FLORIDA, BY DESIGNATING SEVERAL CLASSES AS ADMINISTRATIVE ASSISTANTS TO THE CITY MANAGER, AND PROVIDING FOR SEVERABILITY, REPEAL OF CONFLICTING ORDINANCE PROVISIONS, AND AN EFFECTIVE DATE.

WHEREAS, the City Manager and the Director of Human Resources have recommended an amendment to the Pay Plan of the City of Fort Lauderdale, Florida; and

WHEREAS, the City Manager and Director of Human Resources have recommended that Section 20-83 of the Code of Ordinances of the City of Fort Lauderdale, Florida be amended to designate new classes of employees as administrative assistants of the City Manager; and

WHEREAS, the City Commission agrees with the recommendations of the City Manager and Director of Human Resources to amend the Pay Plan of the City of Fort Lauderdale, Florida, and Section 20-83 of the Code of Ordinances of the City of Fort Lauderdale, Florida,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That Schedule X of the Pay Plan of the City of Fort Lauderdale, Florida, is hereby created, and contains the following classes:

The following professional managerial and administrative employees in the office of the City Manager are administrative assistants to the City Manager: Administrative Assistant, Administrative Assistant I, Administrative Assistant II, Assistant to the City Manager, Structural Innovation Manager, Budget Manager, Public Affairs Manager, Neighbor Services Manager, Assistant Budget Manager, Assistant Manager of CIP (Community Investment Plan)/Grants, Financial Management Analyst, Senior Financial Management Analyst, Principal Financial Analyst, Performance Analyst, and Senior Performance Analyst, <u>CRA</u> Administrative Specialist, CRA Economic Development Program Aide, CRA Accounting Clerk, CRA Administrative Aide, CRA Project Coordinator, CRA Housing & Economic Development Assistant, CRA Planner, CRA Project Manager, CRA Business Manager, CRA Senior Project Manager, and CRA Housing & Economic Development Manager.

<u>SECTION 4</u>. That if any clause, section, or other part of this Ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby, but shall remain in full force and effect.

<u>SECTION 5</u>. That all ordinances or parts of ordinances in conflict herewith, be and the same are hereby repealed to the extent of such conflict.

<u>SECTION 6</u>. That this Ordinance shall be in full force and effect immediately upon its final passage.
