## **ORDINANCE NO. 18-107**

AN ORDINANCE AMENDING THE ZONING CHAPTER OF THE MUNICIPAL CODE OF THE CITY OF FORT STOCKTON, TEXAS, ALLOWING FOR A MANUFACTURED-MOBILE HOME BY SPECIFIC-USE PERMIT IN A SINGLE FAMILY-4 (SF-4) RESIDENTIAL DWELLING DISTRICT; BEING LOTS ONE (1), TWO (2) & THREE (3), BLOCK 260, ORIENT ADDITION FOR THE PLACEMENT OF A MANUFACTURED-MOBILE HOME, IN ACCORDANCE WITH SECTION 7(1), 7(2) & 7(16) OF THE ZONING ORDINANCE AND PROVIDING FOR AN EFFECTIVE DATE PROVISION.

WHEREAS, a petition for allowing a Manufactured-Mobile Home in a Single Family-4 (SF-4) Residential Dwelling District by Specific-Use Permit, as allowed in Sections 7(1), 7(2) & 7(16), Appendix B of the Zoning Ordinance has been duly presented to the City Council of Fort Stockton, Pecos County, Texas by Property Owner Shane Robertson, Fort Stockton, Texas; &

WHEREAS, the same petition was also presented to the Planning and Zoning Commission of the City of Fort Stockton; &

WHEREAS, a Public Hearing was held by the Planning and Zoning Commission on March 14, 2018 and City Council on March 27, 2018 after due notice by a newspaper publication as provided by the Zoning Ordinance Procedure.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FORT STOCKTON, PECOS COUNTY, TEXAS:

SECTION 1. That Section 7(1), USE REGULATION DISTRICTS. 7(2) PRIMARY RESIDENTIAL USES & 7(16), SPECIFIC-USE PERMITS, is hereby amended:

TO ALLOW A MANUFACTURED-MOBILE HOME BY SPECIFIC-USE PERMIT IN A SINGLE - FAMILY (SF-4) RESIDENTIAL DWELLING DISTRICT; BEING LOTS ONE (1), TWO (2) & THREE (3), BLOCK 260, ORIENT ADDITION, AS ALLOWED IN THE ZONING ORDINANCE.

**SECTION 2.** <u>DATE OF EFFECT</u>: This Ordinance shall be in effect immediately upon its adoption and publication as provided by law.
