

ORDINANCE NO. O-01-12

Amending City Code Section 34-31 to Revise Council District Boundaries

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GADSDEN, ALABAMA, as follows:

Section 1. Section 34-31 of the Gadsden City Code is amended to read as follows:

Sec. 34-31. Council districts.

The city is hereby divided into seven council districts as provided in this section:

(1) *District 1.* District 1 shall be as follows: Begin at a point where Goodyear Avenue intersects with the city limits line; thence in a westerly direction along Goodyear Avenue to Hoke Street; thence in a westerly direction along Hoke Street to Litchfield Avenue; thence in a southerly direction along Litchfield Avenue to 15th Street North; thence in a southwesterly direction along 15th Street North to the CSX Transportation, Inc. Railroad; thence in a southeasterly direction along the CSX Transportation, Inc. Railroad to 16th Street North; thence in a southwesterly direction along 16th Street North to East Broad Street; thence in a northeasterly direction along East Broad Street to Tennessee Avenue; thence in a westerly direction along Tennessee Avenue to Fuller Street; thence in a southerly direction along Fuller Street and Paden Drive to Eastview Avenue; thence in a westerly direction along Eastview Avenue to Padenreich Avenue; thence in a southerly direction along Padenreich Avenue to Knucklewood Street; thence in a westerly direction along Knucklewood Street to Riverside Drive; thence in a southerly direction along Riverside Drive to a point where Riverside Drive intersects with the south line of Lot 8, Block 3 of the Rolling Green Farm Tract No. 1 (south line of Lot 8 is also the city limits line); thence in a in a westerly direction along the city limits line to a point where the city limits line intersects with the east bank of the Coosa River; thence in an easterly and in a southerly direction along the meanderings of the city limits line to the intersection of West Air Depot Road and Rains Air Depot Road; thence in a northerly direction along the city limits line to the point of beginning.

Section 2. The provisions of this ordinance shall be effective on publication following pre-clearance by the Voting Rights Section of the Civil Division of the United States Department of Justice or as otherwise provided by the Voting Rights Act.

Section 3. The sections, subsections, paragraphs, sentences, clauses and phrases of this ordinance are severable. If any section, subsection, paragraph, sentence, clause and phrase of this ordinance is declared unconstitutional or invalid by a valid judgment of a court of competent jurisdiction, such judgment shall not affect the validity of any other section, subsection, paragraph, sentence, clause and phrase of this ordinance. The city council declares that it is its intent that it would have enacted this ordinance without such invalid or unconstitutional provisions.

Section 4. The provisions of this ordinance repeal any prior ordinance or provision of the Gadsden City Code to the extent of any conflict.
