READING AND ADOPTION: NOVEMBER 5, 2019

At the regular meeting of the Gwinnett County Board of Commissioners held in the Justice and Administration Center, Auditorium, 75 Langley Drive, Lawrenceville, Georgia.

On motion of Commissioner Brooks, which carried a 4-0 vote, the Gwinnett County Administration Ordinance in Chapter 2 of the Code of Ordinances of Gwinnett County is hereby amended by deleting Division 3 in Article V.

WHEREAS, the Business License and Tax Rate Review and Appeal Committee was established to hear appeals related to the administration of the occupation tax ordinance; and

WHEREAS, the Licensing and Revenue Board of Appeals was subsequently created to hear appeals related to administration of the occupation tax ordinance and alcoholic beverages ordinances; and

WHEREAS, the Business License and Tax Rate Review and Appeal Committee is inactive and no longer needed to provide businesses a forum to appeal administrative decisions; and

WHEREAS, the Board of Commissioners finds that the following amendments to the Administration Ordinance will maintain the health, safety, convenience, order, prosperity, and welfare of the present and future residents of Gwinnett County; and

WHEREAS, the Board of Commissioners finds that adoption of the amendments is in the best interest of Gwinnett County and its residents, visitors, and workers; and

NOW, THEREFORE, BE IT RESOLVED that the Gwinnett County Administration Ordinance in Chapter 2 of the Code of Ordinances of Gwinnett County is hereby amended by deleting Division 3 in Article V, as indicated in "Attachment A."

BE IT FURTHER RESOLVED that all ordinances, regulations or parts of the same in conflict with this Ordinance are hereby rescinded to the extent of said conflict.
