ORDINANCE ENTITLED: Speed Zone Ordinance

At the regular meeting of the Gwinnett County Board of Commissioners held in the Gwinnett Justice and Administration Center, Auditorium, 75 Langley Drive, Lawrenceville, Georgia.

On motion of Commissioner Carden, which carried a by a vote of **5-0**, the Code of Ordinances of Gwinnett County is hereby amended by deleting the existing Speed Zone Ordinance List Number 0135-03-2017 in its entirety and replacing it with a new Speed Zone Ordinance List.

WHEREAS, Gwinnett County is authorized by state law, Official Code of Georgia Annotated Section 40-06-181 and 40-06-183, and the Gwinnett County Code of Ordinances Section 102-3 authorizes the Gwinnett County Board of Commissioners to designate speed zones and to regulate speed limits within Gwinnett County; and

WHEREAS, this is a legal and binding document and any unauthorized changes will cause it to be void in its entirety; and

WHEREAS, Gwinnett County adopted the Speed Zone Ordinance in June 2017 in accordance with state law; and

WHEREAS, the Gwinnett County Board of Commissioners finds it necessary to amend the Speed Ordinance to update the terminology, rules and to include the County's expanded roadway system; and

WHEREAS, the Board of Commissioners finds that adjustments are necessary for school zone boundaries and to modify speed limits on a number of roadways within the County to protect the health and safety of the citizens within Gwinnett County; and

WHEREAS, the Board of Commissioners also finds that the use of radar detection devices on any state route, county road, or city street within the Gwinnett County is required to better safeguard the public safety on the roadways within Gwinnett County; and

WHEREAS, this Ordinance shall become effective for radar use when approved by the Georgia Department of Public Safety and the appropriate signs are erected; and

WHEREAS, the Board of Commissioners finds that the Ordinance amendments better safeguard the public health, safety, and general welfare of the citizens within Gwinnett County; and

WHEREAS, the Board of Commissioners finds that the adoption of the new Speed Zone Ordinance List is in the best interests of the residents of Gwinnett County.

NOW, THEREFORE, BE IT RESOLVED that the existing Gwinnett County Speed Zone Ordinance is hereby amended by deleting Speed Zone Ordinance List Number 0135-03-2017 in its entirety and replacing it with a new Speed Zone Ordinance List which is attached hereto as Exhibit A.

NOW, THEREFORE, BE IT FURTHER RESOLVED that this Ordinance shall be effective upon adoption.

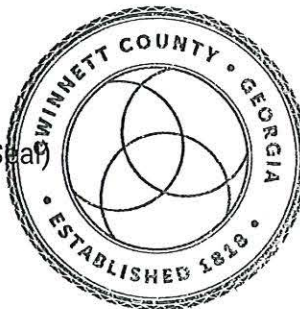
