## ORDINANCE NO. 2025-01

## AN ORDINANCE TO AMEND CHAPTER 7 SECTION 7-2 OF THE CODE OF ORDINANCES TO CHANGE VOTING PRECINCTS

The City of Harper Woods Ordains:

SECTION 1. That Chapter 7, Sec. 7-2 be and is hereby amended to read:

Sec. 7-2 Voting Precincts

The City is hereby divided into three (3) voting precincts which shall be numbered, located and bounded as follows:

Precinct 1 - Beacon Elementary School

Bounded on the west by Kelly Road and the west city limits; on the south between Washtenaw Street and Kingsville Street, and Kingsville Street and the south city limits; on the east by Duprey Avenue, Peerless Avenue, and Beaconsfield Road; on the north by Eight Mile Road and the north city limits.

## Precinct 2 - Harper Woods City Hall

Bounded on the west by Duprey Avenue, Peerless Avenue, and Beaconsfield Road; on the north between Damman Street and Kenmore Drive; on the east by Arthur Avenue, Chester Avenue, I-94, Craig Avenue, Leslie Avenue, and between Rolandale Avenue and Eastborne Avenue; and on the south by the south city limits.

Precinct 3 - Wayne County Community College University Center

Bounded on the west by Beaconsfield Road; on the north by Eight Mile Road and the north city limits; on the east by the east city limits; and on the south between Manchester Boulevard and Allard Avenue, Huntington Boulevard between Arthur Avenue and Chester Avenue, and between Damman Street and Kenmore Drive. An exclave of Precinct 3 is located in the southeast corner of the City, and is bounded on the west between Rolandale Avenue and Eastborne Avenue; on the north by Borurnemouth Avenue; on the east by the east city limits; and on the south by the south city limits.

<u>SECTION 2.</u> <u>REPEAL</u> All Ordinances, or parts of ordinances, in conflict herewith are hereby repealed only to the extent necessary to give this ordinance full force and effect.

<u>SECTION 3.</u> <u>SEVERABILITY</u> If any article, section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by

any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions of this ordinance, it being the intent of the Council of the City of Harper Woods that this ordinance shall stand, notwithstanding the invalidity of any article, section, subsection, sentence, clause, phrase or portion thereof.

<u>SECTION 4. EFFECTIVE DATE</u> It is declared that this ordinance is immediately necessary for the preservation of the public peace, health or safety and as such it shall be of immediate effect.
